THE APPLICATION of Deloitte Restructuring Inc. ("**Deloitte**"), in its capacity as Court-appointed Receiver and Manager (the "**Receiver**") of the assets, undertakings and properties of Network Intelligence Inc., coming on for hearing at Vancouver, British Columbia, by way of MS Teams or Teleconference on Thursday, the 2<sup>nd</sup> day of September, 2021; AND ON HEARING Jonathan B. Ross, counsel for the Receiver, and no one else appearing although duly served; AND UPON READING the material filed, including the Fifth Report of the Receiver dated June 30, 2021 (the "**Report**");

THIS COURT ORDERS AND DECLARES THAT:

1. Good service of this Notice of Application has been made on all interested parties;
2. The activities of the Receiver, as set out in the Report, are hereby approved;
3. The fees, receipts and disbursements of the Receiver and its counsel, as set out in the Report and the first Affidavit of Jeff Keeble, sworn May 28, 2021 (the "**Deloitte Fee Affidavit**")

and the first Affidavit of Jonathan B. Ross, sworn June 17, 2021 (the "Gowling Fee Affidavit"), filed herein, are hereby approved;

4. The Receiver is hereby authorized to pay all the outstanding fees and disbursements of the Receiver as herein approved and after such payment is made, the Receiver shall pay all funds remaining in its hands to NetInt Technologies Inc;

5. Deloitte is hereby released and discharged from any and all claims of any nature and kind whatsoever that any party or person may now have or may hereafter have against Deloitte by reason of or in any way related to or arising out of the acts or omissions of Deloitte while acting as Receiver herein and including, without limitation, any claim or liability relating to matters that were raised or which could have been raised in the within proceedings, except for gross negligence or wilful misconduct;


6. The Receiver is hereby discharged as the Receiver of the assets, undertaking and property of Network Intelligence Inc.;

7. Notwithstanding its discharge herein:

- (a) the Receiver shall remain the Receiver for the performance of incidental duties as may be required to complete the administration of the receivership herein; and
- (b) Deloitte shall continue to have the benefit of the provisions of any orders made in this proceeding including all approvals, protections and stays of proceedings in favour of Deloitte, in its capacity as Receiver;


8. The requirement for the signature of counsel appearing on this Order, other than counsel for the Receiver, is hereby dispensed with.
