UPON the application of Ernst & Young Inc., in its capacity as the Court-appointed Monitor of the UBG Group of Companies (the "Monitor"); AND UPON reviewing the Bridges Report of the Monitor dated October 3, 2013 and the Supplemental Bridges Report of the Monitor dated November 13, 2013; AND UPON hearing counsel for the Monitor, counsel for The Toronto-Dominion Bank and counsel for Lear Construction Ltd. ("Lear") and Paycon Holdings Ltd. ("Paycon"); AND UPON noting that:

- (a) on February 21, 2013, this Honourable Court approved the sale of the following property to Rose Calgary Bridges Limited Partnership ("Rose") (the "Bridges Order"):
  - (i) the sale by UBG Bridges Limited Partnership, of its limited partnership units in The Bridges Limited Partnership (the "Units"); and
  - (ii) the sale by UBG Builders Inc., of its shares in The Bridges Management Inc. (the "Shares");
- (b) Rose paid the Purchase Price (as defined in the Bridges Order) with respect to the Units and the Shares;
- (c) thereafter, the remainder of the Purchase Price constituting the Claims Reserve (as defined in the Bridges Order), in the amount of \$1,300,000, has been held in trust;
- (d) the Claims Reserve constitutes the remaining proceeds of the sale of the Units and Shares; and
- (e) on November 27, 2013, this Honourable Court ordered that \$112,960 from the Claims Reserve be paid to Lear and such payment has been made, leaving \$1,187,039.75 remaining in the Claims Reserve (the "Claims Reserve Balance");

## IT IS HEREBY ORDERED AND DECLARED THAT:

1. TD is entitled to receive 50% of the Claims Reserve Balance, namely \$593,519.87.

2. Paycon is entitled to receive 50% of the Claims Reserve Balance, namely \$593,519.87.

3. There shall be no costs of this application.
