("Cojax", and collectively, the "Kingsley Group") shall, by no later than 4:00 p.m. on Friday, February 7, 2025, provide to counsel for the Bank a list of all of the Kingsley Group's existing bank accounts, wherever situated: 199
- (b) from the date of this Order to the Hearing Date, the Kingsley Group shall:
 - deposit any funds obtained from any source or in the ordinary course of business to the Kingsley Group's accounts held with RBC;
 - (ii) operate only in the ordinary course of business, and not dispose of any of its assets outside of the ordinary course of business; and
 - (iii) permit Deloitte Restructuring Inc., the court-appointed monitor of the Petitioners (in such capacity, the "Monitor"), to have access to the Kingsley Group's physical assets and property in order to, among other things, take an inventory of the same.
- 2. The Kingsley Group, and any other party to these proceedings, shall have liberty to apply to this Court for directions with respect to the terms of this Order on 48 hours' notice to the Kingsley Group and those parties listed on the Service List maintained by the Monitor in these proceedings.
