- 2. Capitalized terms used in this Affidavit shall have the same meaning as used in the Receiver's Third Report or the Vesting Order (defined below) unless otherwise defined herein.

- 3. The Receiver obtained an Order dated April 6, 2010 approving a sale of the Weststone Property and vesting title (the "Vesting Order") in the Purchaser's nominee "Gladstone YK Property Inc.".
- 4. The Purchaser subsequently advised the Receiver that:
  - (a) the Purchaser was unable to obtain from Corporate Registry the name used in the Vesting Order and wanted title to the property transferred into a different corporate name:
  - (b) although the Purchaser's financing was in place the lender needed further time to advance funds and therefore sought an extension of the closing to May 6, 2010.
- 5. The Receiver agreed to these terms in return for the Purchaser increasing the amount of its deposit by \$75,000.
- 6. Attached to this my Affidavit, and marked as Exhibit "A" is a copy of an Amending Agreement with respect to the Sale Agreement which has been signed by counsel for the Receiver and Purchaser (the "Letter Amending Agreement").
- 7. The Receiver seeks an Order approving the Letter Amending Agreement and varying the Vesting Order to properly reflect the proper name of the Purchaser.
