ON THE APPLICATION of Deloitte Restructuring Inc., as court appointed receiver (in such capacity, the "**Receiver**"), without security, of certain lands, other assets and property of Whitewater Concrete Ltd., a creditor of Trilogy Concrete 2021 Ltd. ("**Trilogy**"), Whitewater Developments Ltd. and 146 Golden Drive Ltd., coming on for hearing at 800 Smithe Street, Vancouver, British Columbia on March 12, 2025; and on hearing Noor Mann, counsel for the Receiver, and those other counsel listed on **Schedule "A"** hereto, and on reading the materials filed herein, including the Affidavit #1 of Jeff Keeble, made February 4, 2025;


AND IT APPEARING to the Court that the following acts of bankruptcy have been committed: Trilogy ceased to meet its liabilities generally as they became due;

THIS COURT ORDERS that:

1. Trilogy Concrete 2021 Ltd., a company incorporated pursuant to the laws of British Columbia, of Unit 2 – 107 Kings Road West, North Vancouver, British Columbia, be adjudged bankrupt by virtue of a bankruptcy order made on this date.
2. Deloitte Restructuring Inc., of 410 West Georgia Street, Vancouver, British Columbia, be appointed as the trustee (the "**Trustee**") of the estate of the bankrupt.

3. The Trustee shall give security in cash or by bond or suretyship without delay, in accordance with subsection 16(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3.
4. The costs of the Receiver be paid out of the estate of the bankrupt upon taxation of the estate.
5. Endorsement of this Order by counsel appearing on this application, other than counsel for the Receiver, is hereby dispensed with.
