Notice to the creditors of Vered Wealth Management (Canada) Company Limited

Please take notice that on August 19, 2024, Deloitte Restructuring Inc. ("**Deloitte**") was appointed liquidator (the "**Liquidator**") for Vered Wealth Management (Canada) Company Limited ("**Vered**" or the "**Corporation**") under Division 3 Part 10 of the *Business Corporations Act* (British Columbia) (the "**Act**"). A copy of the shareholders resolution appointing Deloitte is attached for your reference.

A notice of the liquidation and dissolution was published in the British Columbia Gazette on August 22, 2024 (the "**Notice**").

Based on Vered's books and records, you have been identified as a vendor/creditor. A summary of Vered's known vendors/creditors and the amounts the Liquidator has accepted as the amounts that are owed by Vered to each vendor/creditor as at the date of this notice is attached hereto as **Appendix "A"**. If you agree with the Liquidator's assessment of your claim, no further action is required and your claim will be paid in due course..

Pursuant to Section 331(3)(d) of the Act, you may not pursue any claim for any money owed by Vered that is in excess of the amount as set out in Appendix "A" unless, by December 22, 2024 (i.e. within four (4) months after the date on which the Liquidator published the Notice in the Gazette) you:

- (a) satisfy the Liquidator that a greater amount is owing to you; or
- (b) dispute the amount owing by bringing a legal proceeding to dispute the amount or otherwise satisfy the court that a greater amount is owing.

If you disagree with the amount owing, please submit the details of your claim, along with supporting evidence to the Liquidator for its review via email at calgaryrs@deloitte.ca or via regular mail to the following address:

Failure to satisfy the Liquidator that a greater amount than that listed in Appendix "A" is owed to you or to bring a legal proceeding to dispute the amount by December 22, 2024 will result in you being barred from seeking payment greater than that set out in Appendix "A".
