WHEREAS

- A. Pursuant to the Order of the Supreme Court of Nova Scotla in Hfx. No. 454744 dated April 10, 2017, and titled "Sale Approval and Vesting Order", the sale of certain assets by Victory Farms Incorporated and Jonathan Mullen Mink Ranch Limited (the "Declarants") to North American Fur Auctions Inc. ("NAFA") or its nominee was ordered and approved, said sale to include all the right, title and interest of the Declarants in and to "any rights to AgriStability payments";

All sums paid to the Declarants or otherwise received by the Declarants on account of those AgriStability payments shall be received and held in trust for the Beneficiary and none of those sums paid or otherwise received by the Declarants shall be commingled with any other funds of the Declarants or held or deposited in any account in which or to which any other funds are or may be held or deposited;
- 4. At the request of the Beneficiary, the Declarants shall immediately pay all sums received on account of AgriStability payments to the Beneficiary or to such person as the Beneficiary in writing may direct;
- 5. In this Declaration of Trust, a reference to the Declarants shall be deemed to include reference to each of the Declarants individually and, accordingly, this Declaration of Trust shall be read and construed with such grammatical changes, including with respect to number and tense, as may be required by the context; and
- 6. This Declaration of Trust shall be binding upon each of the Declarants and their respective successors and assigns and it shall enure to the benefit of each of NAFA and the Beneficiary and their respective successors and assigns.
