**TO THE CREDITORS OF TOUR TECH. EAST LIMITED (“Tour Tech” or the “Company”)**

Dear Sir/Madam:

Please be advised that Tour Tech has filed a Notice of Intention to Make a Proposal (“NOI”) under Subsection 50.4(1) of the Bankruptcy and Insolvency Act. The effective date of the filing of the NOI is February 20, 2015. Under the Proposal, Deloitte Restructuring Inc. (“Deloitte”) has been appointed as Trustee (“Proposal Trustee”).

The effect of filing a NOI is an automatic stay against all creditors from commencing any actions against the Company. The Company has 30 days to make a Proposal to its creditors or seek an extension from the Court to make a Proposal at a later date.

Included with this letter is a copy of the NOI, a copy of the Consent of the Proposal Trustee to act and a list of known creditors as at the effective date of filing.


The undersigned, being the sole Director of the Corporation, hereby consents to the following resolution:
