

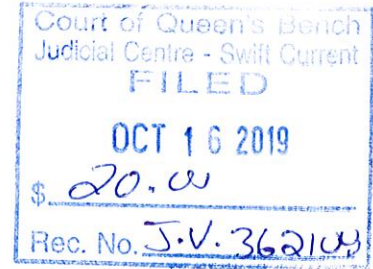

**ORDER**  
**(Abridgement of Time for Service)**

Before the Honourable Mr. Justice R.S. Smith in chambers the 16<sup>th</sup> day of October, 2019.

On the application of Randall M. Sandbeck, Q.C. and Shelley L. Joyce, lawyers on behalf of the plaintiff, Innovation Credit Union, and on reading the Application Without Notice and proposed form of draft Order, all filed, and the pleadings and proceedings herein:

The Court orders:

1. Service of the First Report by the Interim Receiver, Deloitte Restructuring Inc., (the "Report") associated with the application by the Plaintiff, Innovation Credit Union ("Innovation"), for an extension of the Interim Receivership Order respecting the assets, undertakings and properties of the Defendant, Swift Hotels Group Ltd. shall be and is hereby deemed to be good and valid and, further, shall be and is hereby abridged, such that service of the Report is deemed to be timely and sufficient, provided that:
  - a. The Report is served on or before 5:00 p.m. on Tuesday, October 15, 2019, on all parties who appear, based upon the records of the Plaintiff, to have an interest in these proceedings, as more particularly described in the Service List maintained in respect of these proceedings as it exists on that date; or

- b. The respondent to be served consents to the jurisdiction of this Honourable Court to consider the application notwithstanding that the materials in support thereof were not served upon such respondent at least 7 days prior to the hearing of the application as required by the Interim Receivership Order dated September 20, 2019.
