(collectively, the "Applicants"), and upon reading the Notice of Application dated January 22, 2018, the First Report of the Monitor dated January 16, 2018, the Second Supplementary Affidavit of Jaimey Midtdal sworn January 16, 2018, the Brief of Law dated January 16, 2018 and a proposed draft Order, all filed; and the pleadings and proceedings herein; and upon hearing from counsel present:

The Court orders:

- 1. Paragraphs 1 to 22 of the Initial Order of the Honourable Mr. Justice N.G. Gabrielson granted on December 20, 2017 in these proceedings (the "Initial Order"), and the stay of proceedings provided for therein, shall be and is hereby further extended from the current expiry date of 11:59 p.m. Saskatchewan Time on Wednesday, January 24, 2018 to 11:59 p.m. Saskatchewan Time on January 31, 2018.
- 2. Further proceedings pursuant to the Initial Order having been stayed by Order of the Court of Appeal For Saskatchewan, the application by the Applicants to extend paragraphs 23 to 61 of the Initial Order is adjourned sine die, with the return date of such application to be no sooner than the date that is thirty days after the date on which the appeals of the Initial Order by Industrial Properties Regina Limited, 101297277 Saskatchewan Ltd. and Affinity Credit Union 2013 are heard and decided by the Court of Appeal For Saskatchewan.
