Gabrielson (the "**Initial Order**") pursuant to the *Companies' Creditors Arrangement Act*, RSC 1985, c C-36 (the "**CCAA**"), and the stay of proceedings provided for therein, on an interim basis.
2. Such further and other relief as counsel may request and this Honourable Court may permit.

**Grounds for making this application:**

3. The Applicants' application to amend and restate the Initial Order in these proceedings is scheduled to be heard on Friday, May 25, 2018. The deadline for the service of the Applicants' materials in support of this application was set, by Order of this Honourable Court, at Tuesday, May 22, 2018.
4. The Applicants and their secured creditors (IPR Capital Ltd. (successor to Affinity Credit Union 2013), Industrial Properties Regina Limited, and 101297277 Saskatchewan Ltd.) are engaged in ongoing dialogue regarding the potential resolution of the outstanding issues between them. Accordingly, such parties are in agreement that a further extension of the Initial Order to June 7, 2018 is appropriate.
