The proper name of the claimant and its complete address, to which all notices or correspondence are to be forwarded, must be shown.

The proof of claim form must be completed by a person, not by a corporation. The person completing the proof of claim form on behalf of a corporation shall indicate his official capacity, such as "Credit Manager", "Secretary", "Authorized Agent", etc.

A proper proof of claim must be supported by a Statement of Account, marked "A", providing details, such as date, invoice numbers and amounts owing, the total of which agrees with the amount indicated on the claim.

All sections of the proof of claim must be completed. Any non-applicable wording should be crossed out.

The signature of the creditor or declarant on the claim must be witnessed.

TRUSTEE'S REPORT TO CREDITORS ON PRELIMINARY ADMINISTRATION

The Bankruptcy and Insolvency Act provides for a first meeting of creditors. The purpose of this Report is to provide information to the creditors of the Bankrupt for consideration at the first meeting of creditors.

SECTION A - BACKGROUND

On March 22, 2019 (the "**Date of Bankruptcy**"), DistinctTech Inc. became a bankrupt as the result of an assignment in bankruptcy filed by the Receiver (as defined below) pursuant to the terms of the Receivership Order (as defined below). Deloitte Restructuring Inc. ("**Deloitte**" or in such capacity, the "**Trustee**") was named as trustee of the bankrupt estate pending affirmation at the first meeting of creditors.

On March 11, 2019, Deloitte was appointed as Receiver and Manager (in such capacity, the "Receiver") of Distinct and its affiliates by Order of the Ontario Superior Court of Justice (the "Court"). Creditors can access a copy of the aforementioned appointment order issued on March 11, 2019 (the "Receivership Order"), subsequent Court orders, the reports of the Receiver filed to date and other information on the activities of the Receiver, from the Receiver's website (the "Website") at:

http://www.insolvencies.deloitte.ca/en-ca/diq

The largest creditor of Distinct is the Royal Bank of Canada ("RBC") who is owed approximately \$53.3 million at the date of the Receivership Order pursuant to a credit agreement (the "RBC Credit Agreement") between RBC and Distinct's parent company, Distinct Infrastructure Group Inc. (the "Parent"). Pursuant to the terms of the RBC Credit Agreement, Distinct guaranteed all of the outstanding obligations of the Parent and granted a security interest on all of its present and future property to and in favour of RBC as collateral security for the performance of all obligations owed by Distinct to RBC under its guarantee. Neither the Parent nor Distinct was able to satisfy their secured obligations due under the RBC Credit Agreement. The accounting book value of Distinct's assets at the date of bankruptcy totaled approximately \$9.51 million and all owned assets are subject to RBC's security.

Immediately following the issuance of the Receivership Order, the Receiver contacted Distinct's major customers to determine whether such customers were supportive of the Receiver completing projects that were already in progress. All such customers declined to conduct further business with Distinct and have re-sourced the work that was formerly being delivered by Distinct. Consequently, it was not feasible for the Receiver to continue Distinct as a going concern.

For additional information in respect of the factors leading to the receivership proceeding, please see the Report of the Proposed Receiver dated February 28, 2019, posted on the above-referenced Website.

SECTION B - PRELIMINARY EVALUATION OF DISTINCT'S ASSETS AND DETAILS OF ANY SECURITY INTERESTS

A preliminary evaluation of the assets and liabilities of Distinct as at the Date of Bankruptcy is as follows:

The Trustee notes that the Parent has recently issued press releases and guidance to the public market that its financial statements are misstated and should not be relied upon. The Receiver is aware of material write downs to the Company's accounts, which are described in the pre-filing report filed by Deloitte as proposed Court-appointed receiver that is posted on the Website. As a result, the Trustee cautions that the financial information reported herein is subject to correction and may require updating in subsequent reports to the creditors.

As set out above, the primary assets of Distinct are accounts receivable balances to be collected from Distinct's customers, the two largest of which are Bell Canada ("Bell") and Rogers Communications ("Rogers"). Each of these customers also have significant amounts of inventory inside Distinct's former facility that was used to service their contracts. The Receiver has been in regular contact with both of these parties in order to expedite collections and address any property claims.

As noted in the above table, even if the Receiver realizes all assets in full, there will remain a significant shortfall on the secured indebtedness of the Bank with the result that there will be no funds available for distribution to the unsecured creditors of the estate.

The main creditors of Distinct are comprised of RBC (through the guarantee of the debt) and trade creditors. Other creditors include Distinct's former employees (all of whom were terminated on the date of the Receivership Order) and Canada Revenue Agency ("CRA") for unpaid HST amounts resulting from a Refund Integrity Audit conducted by CRA in respect of an 11-month period in 2014 and 2015. The Trustee understands that Distinct submitted a notice of objection in October 2017 to the CRA but that no resolution has been reached.

The Receiver has administered the employees' Wage Earner Protection Program ("WEPP") applications and responded to employee inquiries. The bulk of the WEPP packages were mailed to employees on March 20 and 21, 2019. 403 packages were mailed to former employees, although this includes a

number of entities related to Distinct that are not subject to this bankruptcy administration. Given the short amount of time between the WEPP mailing and issuance of this report, a limited number of proofs of claim in respect of WEPP have been received by the Receiver. The Receiver will continue to administer the WEPP program on behalf of former employees as required within the receivership proceedings.

Former employees of Distinct who have submitted proofs of claim to the Receiver do not need to resubmit proofs of claim to the Trustee for the purpose of the bankruptcy administration. All accepted claims filed with the Receiver will be accepted by the Trustee, subject to the appropriate reduction in claims paid out under WEPP.

SECTION C - BOOKS AND RECORDS

The Trustee, via the Receiver, has access to available books and records of Distinct. The Receiver has taken an electronic back up of Distinct's file and email servers.

SECTION D - CONSERVATORY AND PROTECTIVE MEASURES

Following its appointment, the Receiver took possession of all of the assets and undertaking of Distinct and remains in possession of the residual owned assets of Distinct. Accordingly, there are no assets in the possession and control of the Trustee at this time.

SECTION E - PROVABLE CLAIMS AND DESCRIPTION OF CREDITORS

Based on a review of Distinct's books and records, there are 255 unsecured creditors owed approximately \$9.1 million. In addition to the security granted by Distinct in favour of RBC, other parties have registered security interests against Distinct as evidenced by the *Personal Property Security Act* search results provided by the Receiver's independent legal counsel in each of the Provinces of Alberta, Manitoba and Ontario. A large portion of leased assets have been, or will be, returned to lessors as the Receiver's legal counsel completes its review in respect of the various security registrations.

These claims are summarized in the table above. The Trustee will update the creditors on proofs of claim received at the first meeting.

SECTION F - LEGAL PROCEEDINGS, REVIEWABLE TRANSACTIONS AND PREFERENCE PAYMENTS

Given the nature of Distinct's business, it is subject to a number of ongoing legal proceedings. Many of these relate to property damage or personal injury claims and are covered by Distinct's insurers. Such insurers have been notified of the Receivership Order.

The Trustee intends to perform an assessment of preferences and transactions at undervalue and will provide an update on the status of this assessment at the first meeting of creditors.

SECTION G - DETAILS OF THIRD PARTY DEPOSITS OR GUARANTEES

As there are no assets in the bankruptcy estate to fund any claims, fees and costs of administration, the Trustee has obtained a limited guarantee from RBC in respect of the costs of administration of the estate, including the fees and disbursements of the Trustee and its legal counsel, in the amount of approximately \$20,000.

SECTION H - TRUSTEE'S INTENTION TO ACT FOR SECURED CREDITORS

For the Receivership administration, the Receiver has obtained and relied upon independent legal advice from: TDS LLP, Thornton Grout Finnigan LLP ("**TGF**") and Aird & Berlis LLP ("**A&B**"). TGF also acts as legal counsel to RBC which is expressly provided for in the Receivership Order for the sake of cost efficiency. Where circumstances warrant, the Receiver has engaged the services of A&B to advise it on

issues that require independent legal advice, including providing its opinion on the validity and enforceability of RBC's security interests in the Province of Ontario.

The Receiver will obtain Court approval prior to distributing any funds to RBC in the receivership proceedings. The Receiver has obtained an independent legal opinion on the validity and enforceability of RBC's security from A&B. A&B's opinion is that, subject to the customary and usual qualifications and limitations of such opinions, RBC's security is valid and enforceable and it has been properly perfected under the PPSA (to the extent required), and would rank in priority to the interest of a trustee in bankruptcy in the assets, properties and undertakings of Distinct, which are located in the Province of Ontario, or, in the case of accounts, where the party obligated to pay an account is a resident of the Province of Ontario.
