TRUSTEE'S REPORT TO CREDITORS ON PRELIMINARY ADMINISTRATION

The *Bankruptcy and Insolvency Act* provides for a first meeting of creditors. The purpose of this report is to provide information to the creditors of the bankrupt for consideration in advance of and/or at the first meetings of creditors.

SECTION A – BACKGROUND

On February 06, 2026 (the "**Date of Bankruptcy**"), E G 869 Rest Acres Limited ("**Rest Acres**" or the "**Bankrupt**"), filed an assignment in bankruptcy pursuant to section 49 of the *Bankruptcy and Insolvency Act* (Canada) (the "**BIA**"). Deloitte Restructuring Inc. ("**Deloitte**" or in such capacity, the "**Trustee**") was named as Trustee of the Bankrupt's estate pending affirmation at the first meetings of creditors (the "**FMO**"). Rest Acres is a holding company that owned [insert property address] used in connection with Brook Restoration Ltd. business operation. This property was sold pursuant to a court approved transaction on February 3, 2026.

Rest Acres was also a guarantor of Brook Restoration Ltd which was placed into receivership on February 3, 2026. Deloitte was appointed the receiver ("Receiver") of Brook Restoration Ltd., Rest Acres, and Swinfin Properties Inc., another guarantor of the Brook Restoration Ltd. debt. The first meeting of creditors would be held on March 5, 2026, at 10:30 am. Creditors who wish to attend the first meeting of creditors should file their proof of claim with the Trustee prior to the start of the meeting

SECTION B – PRELIMINARY EVALUATION OF ASSETS & DETAILS OF SECURITY INTERESTS

Rest Acres is holding company and the owner of the real property municipally known as 869 Rest Acres, Brantford (Paris), Ontario which was mortgaged to National Bank of Canada (“NBC”) who is also the secured creditor of the bankrupt.

SECTION C – BOOKS & RECORDS

The Trustee is in process of obtaining digital copy of Rest Acres’s books and records.

SECTION D – CONSERVATORY & PROTECTIVE MEASURES

The company has no operations or other assets and no further action was required by the Trustee to secure the estate.

SECTION E – PROVABLE CLAIMS AND DESCRIPTION OF CREDITORS

The claims of creditors as per Rest Acre’s Statement of Affairs as of February 05, 2026 are summarized below:

SECTION F – LEGAL PROCEEDINGS, REVIEWABLE TRANSACTIONS & PREFERENCE PAYMENTS

The Trustee has not commenced any legal proceedings, and it does not expect to commence any such proceedings prior to the First Meeting of Creditors. The Trustee has not performed a review of Rest Acre’s books and records with respect to potential fraudulent preferences, settlements or transfers at undervalue, as defined in the BIA.

SECTION G – DETAILS OF THIRD-PARTY DEPOSITS OR GUARANTEES

A fee guarantee has been provided by NBC. The costs of the bankruptcy are expected to be covered by funds held by the Receiver of Brook Restoration to the extent that funds are not funded by the Receiver.

SECTION H – PROJECTED DISTRIBUTION AND TRUSTEE COMMENTS ON ANTICIPATED ASSET REALIZATIONS

The Trustee does not anticipate any distribution to creditors.
