#### INTRODUCTION AND PURPOSE OF THIS REPORT

- 1. On March 11, 2019, Deloitte Restructuring Inc. ("Deloitte") was appointed Receiver (in such capacity, the "Receiver"), without security, of all of the assets, undertakings and properties of Distinct Infrastructure Group Inc. (the "Company") and its subsidiaries set out in Appendix "A" hereto (collectively with the Company, "DIG") pursuant to an order (the "Appointment Order") of the Ontario Superior Court of Justice (Commercial List) (the "Court").
- 2. Prior to the issuance of the Appointment Order, Deloitte filed a report to the Court, dated February 28, 2019 (the "Pre-filing Report"). To date, the Receiver has filed with the Court three reports in the receivership proceedings: (i) the First Report dated March 18, 2019, (ii) the Second Report dated April 26, 2019 (the "Second Report"); and (iii) the Special Report dated November 28, 2019 (collectively, the "Previous Reports"), respectively, which, among other things, summarize the activities of the Receiver following its appointment pursuant to the Appointment Order.
- The Appointment Order, the Previous Reports, and other orders, reports and information filed in connection with the receivership proceedings can be accessed on the Receiver's Case Website at <a href="https://www.insolvencies.deloitte.ca/en-ca/dig">www.insolvencies.deloitte.ca/en-ca/dig</a>.
- 4. The main purpose of this third report (the "Third Report") is to provide factual information that may inform or assist the Court in assessing the relief sought by Mega Diesel Holdings Ltd. ("Mega Diesel") and Chris Aron Wood ("Wood" and together with Mega Diesel, the "Moving Parties") in the motion returnable December 17, 2019 (the "Lift Stay Motion") pursuant to which the Moving Parties are seeking an order lifting the stay of proceedings

imposed by this Court in favour of, *inter alios*, the Company and iVac Services West Inc. ("iVac West"), as further described below. This Third Report should not be relied upon for any other purpose. The Receiver will not assume responsibility or liability for losses incurred as a result of the circulation, publication, reproduction or use of this Third Report contrary to the provisions of this paragraph.

5. In support of the Lift Stay Motion, the Moving Parties have served and filed a Motion Record and a Supplementary Motion Record both dated November 5, 2019 (together, the "Mega Diesel Motion Record").

#### **TERMS OF REFERENCE**

- In preparing this Third Report, Deloitte has been provided with, and has relied upon unaudited, draft and/or internal financial information, DIG's books and records, discussions with management of DIG ("Management"), and information from third-party sources (collectively, the "Information"), including the information contained in the Mega Diesel Motion Record. Except as described in this Third Report:
  - a. Deloitte has reviewed the Information for reasonableness, internal consistency and use in the context in which it was provided. However, Deloitte has not audited or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Canadian Auditing Standards ("CAS") pursuant to the *Chartered Professional Accountants Canada Handbook* and, accordingly, the Receiver expresses no opinion or other form of assurance contemplated under CAS in respect of the Information;

- b. the Company previously issued press releases and guidance to the financial markets advising that its financial statements are misstated and should not be relied upon. DIG has made material write downs to DIG's accounts receivable, work in progress, and inventory balances, and accordingly, Deloitte cautions that the financial information reported herein is subject to further verification and may require material revision; and
- c. Deloitte has prepared this Third Report in its capacity as Receiver solely for the purposes noted herein. Parties using the Third Report other than for the purposes outlined herein are cautioned that it may not be appropriate for their purposes.
- 6. Capitalized terms used but not otherwise defined in this Third Report shall have the meaning ascribed to them in the Appointment Order or the Previous Reports, as applicable.
- 7. Unless otherwise stated, all dollar amounts contained in this Third Report are expressed in Canadian dollars.

#### THE LIFT STAY MOTION

8. The Moving Parties have brought the Lift Stay Motion, seeking an Order, among other things, lifting the stay of proceedings (the "Stay") granted pursuant to the Appointment Order as against the Company and iVac West, for the purpose of allowing an appeal in the Court of Queen's Bench of Alberta from the Order of Master Schlosser, dated March 11, 2019 (the "Schlosser Order").

- 9. The Schlosser Order was issued on the same day as the Appointment Order. A copy of the Schlosser Order is attached as **Appendix "B"** to this Third Report.
- 10. The Schlosser Order arises from an action in the Court of Queen's Bench of Alberta, Court File No. 1703-13921 (the "Alberta Action"), involving the Company and iVac West, both of which are part of DIG and subject to terms the Appointment Order and these receivership proceedings. The Alberta Action was commenced by the Moving Parties prior to the date of the Appointment Order. The subject of the Alberta Action involves the determination of the status of certain unsecured Writs of Enforcement registered by the Moving Parties in the Alberta Personal Property Registry over assets of the Company and iVac (collectively, the "Writs"), and priority of claims to the net proceeds of sale from the disposition of certain assets covered by the Writs.

#### Overview of Receivership

- 11. As described in the Previous Reports, each of iVac West and the Company granted security in favour of Royal Bank of Canada ("RBC") over all of their present and future personal and real property as security for certain loans and credit extended by RBC to the Company pursuant to the Credit Agreement. As of February 27, 2019, the Company was indebted to RBC in the amount of \$52.7 million.
- 12. Since its appointment, the Receiver has realized upon substantially all of the assets of DIG that were within its possession and control under these receivership proceedings. On May 3, 2019, the Receiver obtained an Order from the Court, among other things, authorizing and directing it to make an interim distribution to RBC of all funds and receipts held by the Receiver in relation to Crown Utilities Ltd. and Distinct Infrastructure Group West Inc. on

account of the secured indebtedness owing by DIG to RBC, subject only to certain prior ranking claims.

13. As of today, the Receiver is still in possession of proceeds from its realization efforts but has not yet completed its reconciliation or the administration of claims made against DIG by various creditors. As such, the Receiver is not in position to seek a final distribution of the remaining proceeds in its possession. RBC will suffer a substantial shortfall on its loans to DIG.

#### Overview of Alberta Priority Dispute

- 14. A summary of the Alberta proceedings leading up to the issuance of the Schlosser Order is set out in the Affidavit of Chris Aron Wood sworn October 15, 2019 included in the Mega Diesel Motion Record.
- 15. Prior to the Appointment Order, the Moving Parties obtained certain judgments against the Company, Mega Diesel Excavating Ltd. (a predecessor entity of iVac West) and iVac. In connection with such judgments, the Moving Parties registered the unsecured Writs in the Alberta Personal Property Registry against the Company and iVac as follows:
  - i) a Writ of Enforcement in the amount of \$424,789.45 filed on September 1, 2017; and
  - ii) a Writ of Enforcement in the amount of \$154,145.11 filed on October 10, 2018.
- 16. On or around December 11, 2018, Ritchie Bros Auctioneers (Canada) Inc. ("Ritchie Bros") was engaged by DIG to conduct an auction in Edmonton, Alberta and Toronto, Ontario, to sell various equipment owned by DIG.

17. The Writs were registered against the following vehicles owned by the Company and/or iVac, which vehicles were sold at the Edmonton auction (collectively, the "Subject Vehicles"):

- 18. The Receiver understands that the Subject Vehicles were sold at auction in December of 2018.
- 19. A dispute arose with respect to the priority of the Moving Parties' and RBC's interest over the Subject Vehicles, and their respective entitlement to the net proceeds generated from the sale of the Subject Vehicles at auction, resulting in the commencement of the Alberta Action. Specifically, the Moving Parties take the position that RBC waived its senior secured interest over the Subject Vehicles.
- 20. In February 2019, the Company brought an application in the Court of Queen's Bench of Alberta seeking to discharge the registrations of the Writs, and seeking direction of payment of the net proceeds of the sale of the Subject Vehicles to RBC pursuant to RBC's secured indebtedness. Such application was adjourned to allow RBC to be served with the motion.

#### The Schlosser Order and Appeal

21. On the return of the Company's application on March 11, 2019, which the Moving Parties attended, Master Schlosser of the Court of Queen's Bench of Alberta issued the Schlosser Order, which, among order things, ordered that the Writs be discharged and directed Ritchie

- Bros to pay directly to RBC the net proceeds from the sale of the Subject Vehicles, to be applied to the secured indebtedness owing to RBC by iVac.
- 22. The Receiver understands that, pursuant to the Schlosser Order, the Writs have since been discharged and the net proceeds of sale from the Subject Vehicles were paid to RBC directly by Ritchie Bros.
- 23. On March 13, 2019, the Moving Parties filed a Notice of Appeal of the Schlosser Order, and, subsequently, the Brief of the Appellants, dated April 23, 2019 (such appeal is referred to as the "Priority Dispute Appeal").
- 24. The Receiver has never been in possession or control of the net proceeds of sale in dispute.

  These funds were paid by Ritchie Bros to RBC directly on or shortly after the date of the Appointment Order.
- 25. The Receiver was provided with a copy of the letter dated September 9, 2019 from Ontario counsel to the Moving Parties, Birenbaum Steinberg Landau Savin & Colraine LLP ("Birenbaum") which was addressed to Thornton Grout Finnigan LLP ("TGF"), wherein it requests the Receiver's consent to lift the stay of proceedings so that the Moving Parties can pursue their appeal in the Alberta Action. A copy of the letter is attached as Appendix "C" to this Third Report.
- 26. On September 18, 2019, independent counsel for the Receiver, Aird & Berlis LLP ("A&B"), wrote to Birenbaum advising the Moving Parties that the subject sale proceeds had been distributed directly to RBC by Ritchie Bros and that on that basis it was not prepared to consent to the stay of proceedings being lifted as against DIG, and that any further issues

relating specifically to DIG and proceeds of distribution should be dealt with in the receivership proceedings. A copy of the letter dated September 18, 2019 is attached hereto as **Appendix "D"** to this Third Report.

- On October 18, 2019, the Receiver was provided with a copy of a subsequent letter to TGF from Birenbaum advising that Birenbaum had not received a response to its September 9<sup>th</sup> letter. In addition, Birenbaum requested counsel's availability for the Lift Stay Motion. A copy of the letter dated October 18, 2019 is attached hereto as **Appendix "E"** to this Third Report.
- 28. Upon receipt of Birenbaum's October 18<sup>th</sup> letter, A&B emailed Birenbaum enclosing a copy of A&B's September 18<sup>th</sup> letter, and requesting that the Moving Parties coordinate any motion with the Receiver.
- 29. It remains the Receiver's view that the Priority Dispute Appeal is stayed pursuant to the Appointment Order as against the Company and iVac, and, as the proceeds in dispute were paid out concurrently with its appointment (and prior to the Priority Dispute Appeal being filed) The Receiver has not consented to the stay of proceedings being lifted in order to allow the Priority Dispute Appeal to proceed.
- 30. As previously discussed at paragraphs 50 to 52 of the Second Report, the Receiver obtained an independent security opinion from A&B which confirmed that, subject to the normal assumptions and qualifications, RBC's security against the Company is valid and enforceable in accordance with its terms in the Province of Ontario, and that such security interest was properly perfected by registrations under the *Personal Property Security Act*

- (Ontario). A&B's independent security opinion also confirmed that RBC's security is valid and enforceable as against a Trustee in Bankruptcy.
- 31. The Receiver did not obtain an independent security opinion as to the validity and enforceability of RBC's security in Alberta given the nominal value of DIG's assets located in Alberta. However, the Receiver did review the Alberta Personal Property Registry and notes that RBC registered its security thereunder against each of iVac and the Company in respect of a general security agreement. A copy of the search results under the Alberta Personal Property Registry as at March 13, 2019 is attached hereto as **Appendix "F"**.
- 32. The Receiver is of the view that, given the proceeds of sale from the auction of the Subject Vehicles by Ritchie Bros have never been in the hands of the Receiver, there is little value in the Receiver involving itself in the priority dispute between the Moving Parties and RBC.
- 33. If the Court decides to lift the stay in order to allow the Priority Dispute Appeal to proceed, the Receiver suggests that this priority dispute be heard in Ontario within the receivership proceedings. The Receiver should not be required to incur unnecessary costs in participating in a creditor dispute in another province when the Ontario Court would appear to be the appropriate forum for resolving any disputes related to DIG, should the Court determine that the stay of proceedings should be lifted in relation to the Company and iVac.

34. In the light of the foregoing, the Receiver is seeking the advice and direction from this Court with respect to the Lift Stay Motion, and if necessary, to have the Priority Dispute Appeal heard by this Court as part of the Receivership proceeding.







We are counsel to Chris Aron Wood and Mega Diesel Holdings Ltd., creditors of Distinct Infrastructure Group Inc. ("DIG"). We write seeking your consent to lift the stay imposed by the March 11, 2019 Order of Justice Hainey (the "Receivership Order") to allow an ongoing appeal to proceed before the Court of Queen's Bench of Alberta.

As you are aware, prior to the appointment of the Receiver, our clients were attempting to enforce outstanding judgments against DIG (and its related wholly-owned subsidiaries) in Alberta, in the amount of approximately \$575,000.00.<sup>1</sup>

In their attempt to enforce the outstanding judgments, an issue arose as to the priority over certain assets registered in the Alberta Personal Property Registry as between our clients and Royal Bank of Canada (the "Priority Dispute").

Master Schlosser, of the Court of Queen's Bench of Alberta, granted an Order in the Priority Dispute in favour of RBC and DIG, from which our clients have appealed (the "Schlosser Order"). However, as a result of the Receivership Order, our clients are estopped from pursuing their appeal of the Schlosser Order in Alberta.

We understand that our clients' Alberta counsel served your office on or about April 23, 2019 with a copy of the Notice of Appeal in the Priority Dispute, as well as the appeal materials filed with the Court of Queen's Bench of Alberta.

On review of the Receiver's publicly filed materials, there is a substantial risk that there will be no funds available from which our clients may seek to enforce their outstanding judgments.

Given that the Priority Dispute is currently a live issue before the Alberta courts, it is our view that the stay imposed in this matter is resulting in a material prejudice as against our clients and should properly be lifted in order to allow the appeal of the Schlosser Order to proceed.

As such, we seek your written consent, pursuant to the Receivership Order, to lift the stay imposed in order to allow the Appeal of the Schlosser Order.

Should you fail to provide consent to lift the stay, we have instructions to bring a motion forthwith seeking to lift the stay, and will seek costs against the Receiver as a result.

We look forward to receiving your response by <u>no later than Monday</u>, <u>September 16, 2019</u>. Failing which, we will proceed to arrange for a motion on this issue.



Please be advised that we act as independent counsel to Deloitte Restructuring Inc. in its capacity as Court appointed Receiver (in such capacity, the "Receiver") of Distinct Infrastructure Group Inc. et. al. (collectively, the "Debtors") pursuant to the Order of the Ontario Superior Court of Justice (Commercial List) (the "Ontario Court") dated March 11, 2019 (the "Receivership Order")

We are in possession of your letter dated September 9, 2019 addressed to Thornton Grout Finnigan LLP who acted on behalf of Royal Bank of Canada ("RBC") on its application for the Receivership Order.

Your client's appeal addresses a priority issue between your clients, Chris Aron Wood and Mega Diesel Holdings Ltd., and RBC. We understand that the Debtors' collateral which was the subject of the priority dispute has been sold. We understand that pursuant to the Order of Master Schlosser dated March 11, 2019, the proceeds of sale of the Debtors' assets were distributed directly from Ritchie Bros. Auctioneers (Canada) Ltd. to RBC. The Receiver was not, at any time. in possession of such funds. The Receiver is, however, in possession of all of the Debtors' books and records, to the extent that same may be relevant to the dispute.

The Receiver has substantially realized upon all assets of the Debtors that were within its possession or control under the Receivership. The Receivership proceedings in the Ontario Court would appear to be the appropriate forum for resolving any disputes related to the Debtors, including any competing interest in the proceeds of any sale of its assets. Accordingly, the Receiver does not consent to lift the stay of proceedings to allow your client's appeal to proceed in another Province.

Any motion brought by your client in the Ontario Court must be on at least seven (7) days' notice to the Receiver and all affected parties. Should you wish to pursue such motion, please consult the writer and counsel for RBC with respect to the scheduling of any attendance or motion. Thank you for your attention in this regard.

We are counsel to Chris Aron Wood and Mega Diesel Holdings Ltd., creditors of Distinct Infrastructure Group Inc. ("DIG"). We write to canvass dates for a motion seeking to lift the stay imposed by the March 11, 2019 Order of Justice Hainey (the "Receivership Order").

On September 9, 2019, we wrote to counsel for the Receiver, Deloitte Restructuring Inc., seeking the Receiver's consent to lift the stay to allow our clients to pursue an ongoing appeal at the Court of Queen's Bench of Alberta. We have received no response to our correspondence and as such have prepared motion materials for a motion to lift the stay.

Please provide your availability for a short-motion to lift the stay in November and December 2019.

If we do not receive a response from you by October 25, 2019, we will choose a date unilaterally and serve our materials in accordance with the *Rules*.






