NOTICE OF MOTION

(Motion returnable July 17, 2025)

Deloitte Restructuring Inc. in its capacity as receiver and manager ("Deloitte" or the "Receiver") of certain real property of Golden Dragon Ho 10 Inc. ("GDH 10") municipally known as 347 Barber Street, Ottawa, Ontario (formerly known as 347 Clarence Street, Ottawa) ("347 Barber") and of certain real property of Golden Dragon Ho 11 Inc. ("GDH 11" and together with GDH 10, "GDH") municipally known as 345 Barber Street, Ottawa, Ontario (formerly known as 345 Clarence Street, Ottawa) ("345 Barber") (collectively, with 347 Barber, referred to herein as the "Property") will make a motion to the Honourable Mr. Justice Hackland by Zoom videoconference on Thursday, July 17, 2025, or as soon after that time as the Motion can be heard.

PROPOSED METHOD OF HEARING: The Motion is to be heard by videoconference.

THE MOTION IS FOR:

1. If necessary, an Order abridging the time for service and filing of this Notice of Motion and the Receiver's Motion Record such that the Motion is properly returnable on July 17, 2025 and dispensing with further service thereof;

- 2. An Order approving the activities of the Receiver as described in its Eleventh Report to the Court dated April 1, 2024 (the "Eleventh Report") and its Supplement Report to the Eleventh Report dated June 27, 2024 (the "Supplemental Report" and together with the Eleventh Report, the "Reports");
- 3. An Order requiring Liahona Mortgage Investment Corp. ("Liahona") to repay the amount of \$50,000 (the "Funds") to the Receiver so that the Receiver may pay the Funds to Martin Diegel in trust;
- 4. An Order approving the Receiver's Statement of Receipts and Disbursements for the period from September 22, 2017 to June 26, 2025;
- 5. An Order approving the fees and disbursements of the Receiver from February 1, 2021 to March 31, 2024 and the fees and disbursements of Dickinson Wright LLP ("**DW**") from February 4, 2021 to June 11, 2025, as set out in the fee affidavits appended to the Reports;
- 6. An Order discharging the Receiver, subject to the Receiver completing its administration of the estates herein and distributing the remaining funds held by the Receiver; and
- 7. Such further relief as counsel may advise and this Honourable Court may permit.

THE GROUNDS FOR THE MOTION ARE:

- By Order of Justice Hackland dated September 22, 2017 (the "Appointment Order"),
 Deloitte was appointed interim receiver over the Property;
- 2. Deloitte's appointment was later expanded to that of a 'full blown' receiver pursuant to the Expanded Powers Order of Justice Hackland dated May 26, 2019;
- 3. On October 11, 2019, Justice Hackland granted an Approval and Vesting Order approving the Receiver's proposed transaction for the sale of the Property;

- 4. On July 21, 2023, Justice Hackland issued an order approving the distribution of most of the funds held by the Receiver to Liahona and GDH;
- 5. Allocation calculations were provided to both Liahona, through its legal counsel, and Mr. Diegel and on July 25, 2023, the Receiver made distributions to Liahona and Mr. Diegel, leaving the Receiver holding funds totaling approximately \$181,000;
- 6. In preparing the Eleventh Report, the Receiver determined that there had been a formula error in the allocation calculations, which resulted in an overpayment to Liahona of \$50,000;
- 7. On July 16, 2024, counsel for each of the Receiver, GDH and Liahona appeared before Justice Hackland via videoconference;
- 8. Following discussions during the hearing, and the suggestion of counsel for the Receiver, it was agreed, and His Honour accordingly ordered, that the sum of \$125,000 would be paid out to Mr. Diegel in trust, out of the funds remaining with the Receiver. The remaining balance of funds held by the Receiver would be paid out in accordance with a further Order of the Court following further discussions between counsel and the Receiver to resolve the erroneous over-payment of \$50,000 to Liahona and Court approval of the balance of outstanding fees due to the Receiver and DW, and any other unresolved financial issue;
- 9. On July 18, 2024, \$125,000 was wired to Mr. Diegel in trust by the Receiver;
- 10. In the discussions that ensued subsequently between counsel for the Receiver, GDH and Liahona, counsel for Liahona confirmed that Liahona is not agreeable to refunding the \$50,000 overpayment it received.
- 11. On May 16, 2025, counsel for the Receiver, GDH and Liahona re-attended before Justice Hackland via videoconference, at which time His Honour scheduled a hearing to deal with the outstanding issues on July 17, 2025;

Receipts and Disbursements

12. As of June 26, 2026, the Receiver held net funds in this administration of \$61,325.81;

Professional Fees

- 13. The Receiver and its legal counsel have maintained detailed records of their professional time and costs since the issuance of the Appointment Order. Pursuant to paragraph 17 of the Appointment Order, the Receiver and its legal counsel were directed to pass their accounts from time to time before a judge of the Court.
- 14. The fees and disbursements of the Receiver during the period from February 4, 2021 to March 31, 2024 amount to \$26,862.93, inclusive of HST. The Receiver and its staff have not charged any time to this matter since February 29, 2024;
- 15. The fees and disbursements of DW, in its capacity as counsel to the Receiver, for the period from February 4, 2021 to March 28, 2024 amount to \$78,217.67, inclusive of HST;
- 16. The fees and disbursements of DW, in its capacity as counsel to the Receiver, for the period from March 29, 2024, to June 11, 2025 amount to \$10,801.56, inclusive of HST;

- 4. Following discussions during the hearing, and the suggestion of counsel for the Receiver, it was agreed, and His Honour accordingly ordered, that the sum of \$125,000 would be paid out to Martin Diegel in trust, out of the funds remaining with the Receiver. The remaining balance of funds held by the Receiver would be paid out in accordance with a further Order of the Court, following further discussions between counsel and the Receiver to resolve the erroneous over-payment of \$50,000 to Liahona and Court approval of the balance of outstanding fees due to the Receiver and DW, and any other unresolved financial issue. Justice Hackland's endorsement of July 16, 2024 is attached hereto as **Appendix "A"**.
- 5. On July 18, 2024, \$125,000 was wired to Mr. Diegel in trust by the Receiver.
- 6. In the discussions that ensued subsequently between counsel for the Receiver, the Debtors and Liahona, counsel for Liahona confirmed that Liahona is not agreeable to refunding the \$50,000 overpayment it received.
- 7. On May 16, 2025, counsel for the Receiver, the Debtors and Liahona re-attended before Justice Hackland via videoconference, at which time His Honour scheduled a hearing to deal with the outstanding issues on July 17, 2025.
- 8. The total legal fees of DW, in its capacity as counsel to the Receiver, for the period March 29, 2024 to June 11, 2025 amount to \$9,306.00, together with disbursements of \$252.90 and HST of \$1,242.66, totalling \$10,801.56. The time spent by DW is more particularly described in the Affidavit of David Preger, a partner of DW, sworn June 26, 2025, attached hereto as **Appendix "B"**.

- 9. As noted in paragraph 53 of the Eleventh Report, the total outstanding fees of the Receiver are \$17,611.05. The Receiver and its staff have not charged any time to this receivership since February 29, 2024. In particular, the undersigned has not charged any time since taking over the carriage of this receivership in August of 2023.
- 10. The total outstanding fees of DW include \$19,759.38 as noted in paragraph 53 of the Eleventh Report, plus the \$10,801.56 noted in paragraph 8 of this Supplemental Report, for a total of \$30,560.94.
- 11. Accordingly, the outstanding professional fees of the Receiver and DW total \$48,171.99.

SERVICE

1. **THIS COURT ORDERS AND DECLARES** that the time for service of the Receiver's Notice of Motion and Motion Record, including the Eleventh Report and the Supplement, is hereby abridged and validated so that the motion is properly returnable today and hereby dispenses with further service thereof.

RECEIVER'S ACTIVITIES

2. **THIS COURT ORDERS AND DECLARES** that the activities of the Receiver described in the Eleventh Report and the Supplement are hereby approved, provided, however, that only the Receiver, in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.

REPAYMENT OF FUNDS

- 3. **THIS COURT ORDERS** that Liahona shall repay the amount of \$50,000 (the "**Funds**") to the Receiver forthwith.
- 4. **THIS COURT ORDERS** that, upon receipt of the Funds, the Receiver shall pay the Funds to Martin Diegel, in trust.

STATEMENT OF RECEIPTS AND DISBURSEMENTS

5. **THIS COURT ORDERS AND DECLARES** that the Receiver's Statement of Receipts and Disbursements for the period September 22, 2017 to June 26, 2025 contained in the Supplement is hereby approved.

DISCHARGE
