**ENDORSEMENT**

- [1] Defendant Daimler moves for appointment of receiver and establishing urgency re: recovery of multiple transport truck units from plaintiff.
- [2] LAJ Shaw reviewed request for hearing as urgency and endorsed as follows on September 19, 2025 with respect to the terms on which this matter was added to this September 26, 2025 regular Brampton short family/civil motions list:



*If the matter is opposed, the motions judge will determine if the matter can be heard on a regular motions list (59 minutes or less) or if a longer motion date is required. The practice in this region is for parties to attend triage court to either set a timetable for necessary steps to be completed or to set a long hearing date if the timetable has been completed.*

*If the motions judge is of the view that this matter cannot be heard in under 59 minutes, they may also consider whether the matter is urgent and requires an earlier hearing date without proceeding to triage court.*

*Any material uploaded to Case Centre must be hyperlinked. The index is to be hyperlinked as are all exhibits in the affidavit. The plaintiff's 687 page motion record is not hyperlinked. This is unacceptable as counsel are expected to knowhow to properly upload documents after several years of using Case Lines /Case Centre.*

- [3] On the return of this matter before me on the short motions list, counsel for plaintiff, Ms. Singh, confirmed she was instructed to oppose the motion and would be filing materials.
- [4] I determined that a long motion date before a dedicated judge (vs on a short motion list) was required.
- [5] Accordingly the motion shall return and is hereby adjourned to be heard as a ONE HOUR short motion IN PERSON at 10 am on Wednesday October 1, 2025. The moving party was advised that the alternative to a one-hour motions was to wait a month for the next two hour motion availability. The one hour long motion date was preferred.
- [6] Accordingly all parties will have to move swiftly and cooperate as officers of the court to bring this dispute quickly, and in a tidy, focused manner before the court. Moving party/ies will have no more than 25 minutes (shared as needed among counsel supporting receivership order) for argument, responding/objecting party 25 minutes, with any reply in the discretion of the long motion judge.

The following process also ordered:

- [7] Responding plaintiff to serve and file materials on all parties by 3pm on Tuesday Sept 30, 2025. If it is not possible to file, or obtain confirmation of filing from the court office on Tuesday due to Truth and Reconciliation Day service reductions, plaintiff counsel has leave to upload to Case Center no later than 3:30 pm on Tuesday her affidavit of service of responding materials, along with her client's materials, hyperlinked and otherwise complying with the practice direction, along

with a copy of this endorsement authorizing same. This will allow the assigned long motion judge to review and prepare for the motion rather than getting the respondent's materials the morning of the motion.

- [8] Lastly, moving party counsel is to file motion confirmation form attaching a copy of this endorsement and may do so by short service by 2pm on Sept 29, 2025.
- [9] Motion accordingly adjourned on above terms to 1 hour long motion to be argued IN PERSON IN BRAMPTON COURT on October 1, 2025 (Wednesday).
- [10] So ordered. I am not seized.
