SUPPLEMENTAL AFFIDAVIT OF MOHAMMAD ABU-QUBE (sworn September 24, 2025)

I, Mohammad Abu-Qube, of the Town of Milton, in the Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:

1. I am a Manager in the Collections and Loss Recovery group of Daimler Truck Financial Services Canada Corporation ("Daimler")¹. As such, I have personal knowledge of the

matters to which I hereinafter depose except where I have otherwise indicated and in which case I verily believe the facts deposed to be true.

- I previously swore an affidavit in this matter on September 15, 2025 (the "First Abu-Qube
 Affidavit"). Capitalized terms used and not otherwise defined herein are defined in the
 First Abu-Qube Affidavit.
- 3. As with the First Abu-Qube Affidavit, this supplemental affidavit is sworn in support of Daimler's motion for the appointment of Deloitte as Receiver over certain of the Debtor's Property, including but not limited to the Outstanding Vehicles.
- 4. Daimler's motion was brought before the Court on an urgent basis and has now been scheduled for September 26, 2025.

EVENTS SINCE THE FIRST ABU-QUBE AFFIDAVIT

- 5. As set out in the First Abu-Qube Affidavit at all material times the Debtor's principal place of business was in Manitoba. Daimler was recently made aware that the Outstanding Vehicles (among others) had been relocated to a yard located at 2870 Bovaird Drive, Brampton, Ontario. However, once Daimler's bailiffs gained access to the yard, the vast majority of vehicles that had previously been located there had been moved to a location unknown to Daimler and its bailiffs and none of the Outstanding Vehicles remained on the Property. The location of the Outstanding Vehicles remains largely unknown.
- 6. Through its own investigations, Daimler has recently learned that three of the Outstanding Vehicles have been relocated to the United States. Registrations have been filed with various state motor vehicle departments to amend title to the Outstanding Vehicles. These

actions are in clear contravention of the Conditional Sale Contracts and undertaken to further frustrate Daimler's efforts to repossess the Vehicles.

7. Daimler's investigations remain ongoing and, as of the date of this Affidavit, title has been recently amended in the United States on the following Outstanding Vehicles:

- 8. Attached hereto as Exhibit "A" are CARFAX reports dated September 16, 2025 (3AKJHHDR7RSUU8216) and September 22, 2025 (3AKJHHDR7NSNE3056 and 3AKJHHDR9RSUU8217) detailing the title amendments registered in the United States to the above-noted Outstanding Vehicles.
- 9. The actions taken by the Debtor in transporting certain of the Outstanding Vehicles to the United States and amending title were likely taken for the purpose of selling the Outstanding Vehicles to third parties.
- 10. Daimler's concerns regarding the relocation of the Outstanding Vehicles to the United States for the purposes of frustrating Daimler's attempts to repossess them have been borne out by the above-noted title amendments. Although Daimler is taking affirmative steps to try and register its security interest, including through the filing of registrations under the Uniform Commercial Code, the appointment of the Receiver is urgently needed to try and

preserve whatever value may remain in the Outstanding Vehicles before it is completely dissipated by the Debtor.

11. Finally, as set out in the First Abu-Qube Affidavit, Daimler filed a Statement of Defence and Counterclaim in response to the Debtor's Statement of Claim. On September 23, 2025, Daimler filed a requisition to have the Debtor noted in default as a result of it having failed to deliver a Statement of Defence to Daimler's Counterclaim.
