ORDER

(Transfer to the Commercial List)

THIS MOTION, made by Deloitte Restructuring Inc. ("**Deloitte**"), in its capacity as trustee in bankruptcy (in such capacity, the "**Trustee**") of Robert Land Academy ("**RLA**" or, the "**Bankrupt**"), a bankrupt, for an order, *inter alia*, transferring the court proceedings bearing Court File No. BK-26-03241463-0032 in respect of the Estate File No. 32-3241463 commenced in Hamilton to the Ontario Superior Court of Justice (Commercial List) (the "**Commercial List**") was heard this day at 330 University Avenue, Toronto, Ontario, by judicial teleconference via Zoom.

ON READING the Aide Memoire of the Trustee dated September 11, 2026, the responding Aide Memoire of counsel on behalf the plaintiff parties in Court File Nos. CV-25-00015259-0000, CV-25-00015472-0000, and CV-25-00015483-0000 (collectively, the "**Responding Plaintiff Parties**") dated September 11, 2026, the responding Aide Memoire of the insolvency monitoring counsel for the insurers (the "**Responding Insurer Parties**") dated September 14, 2026, the reply Aide Memoire of the Trustee dated September 14, 2026 and the reply Aide Memoire of the Responding Insurer Parties dated September 15, 2026, and on hearing the submissions of counsel for the Trustee, counsel to the Responding Plaintiff Parties, counsel the Responding Insurer Parties, counsel to certain other plaintiff parties with contingent claims against the Bankrupt, a self-represented plaintiff party, and those other parties on the participant information sheet, no one appearing for any other person on the Service List, although duly served as appears from the affidavit(s) of service of Katherine Yurkovich sworn September 11, 2026 and September 14, 2026:

1. **THIS COURT ORDERS** that the within proceeding bearing Court File No. BK-26-03241463-0032 in respect of the Estate File No. 32-3241463 is transferred from the Superior Court of Justice Courthouse at 45 Main Street East, Hamilton, Ontario L8N 2B7 to the Superior Court of Justice Courthouse (Commercial List) at 330 University Avenue, Toronto, Ontario M5G 1R7, without opposition from any party on the Service List, effective as of the date of this Order.
2. **THIS COURT ORDERS** that notwithstanding the transfer of the within proceedings provided in paragraph 1 of this Order, such transfer is provisional and expressly limited to the Commercial List's hearing of a motion to be brought by the Trustee in respect of the approval of a claims process order (the "**Claims Process Order**") for the establishment of a claims protocol (the "**Claims Protocol**") for the summary determination and adjudication of all contingent abuse claims against the Bankrupt, and, to the extent such Claims Process Order is granted, the Commercial List's oversight and administration of the Claims Protocol in accordance with the express terms of the Claims Process Order and shall not extend to a transfer of jurisdiction over underlying claims issued and continued, or to be issued, by claimants against the bankrupt, to the extent that the stay of proceedings imposed under section 69.3 of the *Bankruptcy and Insolvency Act* (Canada) is lifted and such claims proceed or are commenced..
3. **THIS COURT ORDERS** that this Order is effective from the date that it is made and is enforceable without the need for entry and filing.
