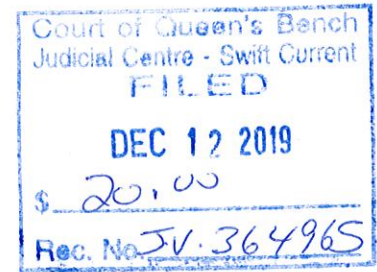

ORDER

(Abridgment of Time for Service)

Before the Honourable Mr. Justice R.S. Smith in Chambers the 11<sup>th</sup> day of December, 2019.

Upon the application by Jeffrey M. Lee, Q.C. and Marek Coutu, counsel on behalf of Deloitte Restructuring Inc. (the "**Receiver**"), in its capacity as Court-Appointed Receiver of Swift Hotels Group Ltd. ("**Swift Hotels**"), and upon reading the Application Without Notice dated December 11, 2019, the Affidavit of Stephanie Chernoff sworn December 11, 2019, and a proposed draft Order, all filed; and the pleadings and proceedings herein;

**The Court orders:**

1. Service of the Notice of Application, Draft Order, First Report of the Receiver, affidavit evidence, Brief of Law and all other materials associated with the application by the Receiver, Deloitte Restructuring Inc., for an Order (collectively, the "**Application Materials**") directing Phil Krahn, Brian Ostrander and/or Odyssey Hotels Group Ltd. to cause the sum of \$52,000.00 to be paid to the Receiver forthwith, shall be and is hereby deemed to be good and valid and, further, shall be and is hereby abridged, such that service of such Application Materials is deemed to be timely and sufficient, provided that:
  - (a) all such materials are served on or before Thursday, December 12, 2019 at 5:00 p.m. (Saskatchewan time) on all parties who appear, based upon the records of the Receiver, to have an interest in these proceedings, as more particularly described in the Service List maintained in respect of these proceedings as it exists on that date; or
  - (b) the respondents to be served consent to the jurisdiction of this Honourable Court to consider the application for the Order notwithstanding that the materials in support thereof were not served upon such respondents at least 14 days prior to the hearing of the application.
