#### **INTRODUCTION**

- 1. Deloitte Restructuring Inc. ("Deloitte") was appointed as interim receiver (the "Interim Receiver"), without security, of all the assets, undertakings, and properties (the "Property") acquired for, or used in relation to the business carried on by Swift Hotels Group Ltd. ("Swift Hotels", the "Company", or the "Debtor"), specifically including the lands legally described as Surface Parcel #144225750 Blk/Par A, Plan No DX1385 Extension 0 (the "Swift Current Hotel"), pursuant to the Order of the Court of Queen's Bench for Saskatchewan (the "Court") dated September 20, 2019 (the "Interim Receivership Order").
- 2. On October 18, 2019, pursuant to an application filed by Innovation Credit Union ("Innovation"), the Court granted an order extending the Interim Receivership Order to and including November 29, 2019.
- 3. On November 28, 2019 (the "Date of Receivership"), pursuant to a further application filed by Innovation, the Court granted an order (the "Receivership Order") discharging the Interim Receiver and appointing Deloitte as the receiver (the "Receiver") of the Property. A copy of the Receivership Order and other information regarding the interim receivership and receivership proceedings can be accessed on the Receiver's website at <a href="https://www.insolvencies.deloitte.ca/en-ca/SwiftGroup">www.insolvencies.deloitte.ca/en-ca/SwiftGroup</a> (the "Receiver's Website").
- 4. This report constitutes the third report of the Receiver (the "**Third Report**"), and is being filed to inform the Court of the following:
  - (a) The activities of the Receiver since the filing of its second report dated December 3, 2020 (the "Second Report");
  - (b) The closing of the Swift Current Hotel sale transaction (the "Sale Transaction") with 12547091 Canada Ltd. (the "Purchaser");
  - (c) The status of the Related Party A/R (as defined below); and
  - (d) The status of the priority dispute between Innovation and Canada Revenue

Agency ("CRA") in respect of CRA's claim against Swift Hotels for \$313,717.67 in unremitted employee source deductions (the "Disputed Priority Funds").

- 5. Further, this Third Report is being filed in support of the Receiver's application to this Honourable Court to be heard on December 6, 2021, seeking the following items of relief:
  - (a) Approval of the reported actions of the Receiver since the filing of the Second Report in administering these receivership proceedings;
  - (b) Approval of the Receiver's Residual Related Party A/R Powers (as defined below);
  - (c) Approval of the fees and disbursements of the Receiver and its legal counsel;
  - (d) Approval of the Receiver's Statement of Receipts and Disbursements for the period November 28, 2019 to November 30, 2021; and
  - (e) An Order providing for the discharge of the Receiver.

#### **TERMS OF REFERENCE**

- 6. In preparing this Third Report, the Receiver has relied upon unaudited financial information, other information available to the Receiver and, where available and appropriate, Swift Hotels' books and records and discussions with various parties.
- 7. The financial information of the Company has not been audited, reviewed or otherwise verified by the Receiver as to its accuracy or completeness, nor has it necessarily been prepared in accordance with generally accepted accounting principles and the reader is cautioned that this Third Report may not disclose all significant matters about the Company or its financial position. Additionally, none of the Receiver's procedures were intended to disclose defalcations or other irregularities. If the Receiver were to perform additional procedures or to undertake an audit examination of the financial statements in accordance with generally accepted auditing standards, additional matters may have come to the Receiver's attention. Accordingly, the Receiver does not express an opinion

nor does it provide any other form of assurance on the financial or other information presented herein. The Receiver may refine or alter its observations as further information is obtained or brought to its attention after the date of this Third Report.

- 8. The Receiver assumes no responsibility or liability for any loss or damage occasioned by any party as a result of the circulation, publication, reproduction or use of this Third Report. Any use which any party makes of this Third Report, or any reliance or decision to be made based on this Third Report, is the sole responsibility of such party.
- 9. Unless otherwise stated, all monetary amounts contained in this Third Report are expressed in Canadian dollars.
- 10. Capitalized terms used in this Third Report but not defined herein are as defined in the first report of the Receiver dated December 19, 2019 (the "First Report"), the Second Report, and the Receivership Order.

#### **ACTIVITIES OF THE RECEIVER**

- 11. Since the filing of the Second Report, the Receiver has undertaken the following activities:
  - (a) Attended the December 18, 2020 Court hearing in these proceedings;
  - (b) Completed the Sale Transaction with the Purchaser, and terminated insurance coverage on the Property upon closing;
  - (c) Terminated all staff retained by the Receiver upon closing the Sale Transaction, and facilitated the transition and employment of staff by the Purchaser;
  - (d) Closed various third-party vendor accounts established by the Receiver to facilitate the uninterrupted operations of the Swift Current Hotel during the receivership proceedings;
  - (e) Coordinated with the third-party property manager, Inntegrated Hospitality Management Ltd. ("IHM"), to obtain all books and records and financial

- reporting related to the operations of the Swift Current Hotel during the proceedings, and terminated the engagement of IHM upon closing of the Sale Transaction;
- (f) Filed statutory returns with CRA (in regard to corporate tax and goods and services tax ("GST")) and with the Saskatchewan Ministry of Finance (in regard to provincial sales tax ("PST"));
- (g) Facilitated communications between CRA and Innovation with respect to the Disputed Priority Funds;
- (h) Continued prosecution of the legal actions in respect of the Related Party A/R, whereby the Receiver had previously filed statements of claim against Odyssey Hotels Group Ltd. (for \$487,488), Ostrander Family Holdings (for \$388,465), Ostrander Family Trust (for \$1,970,000), Swift Hotels Partnership Group Ltd. (for \$61,257), and Swift Hotels Swift Current Group Ltd. (for \$94,438); and
- (i) Prepared, reviewed, and finalized this Third Report.

#### SALE TRANSACTION

- 12. In accordance with the Sale Approval and Vesting Order dated December 18, 2020 (the "SAVO") (attached hereto as Appendix A), the Receiver closed the Sale Transaction with the Purchaser on January 7, 2021 (the "Closing Date"). The Sale Transaction was completed on the Closing Date, and the Receiver's Certificate (attached hereto as Appendix B) was filed with the Court on May 7, 2021, and was entered on May 10, 2021.
- 13. As the Receiver continued to offer credit to the Company's corporate customers prior to the Closing Date, and continued to collect operating receipts subsequent to the Closing Date (at the request of the Purchaser) while the Purchaser established its payment processing accounts, the Receiver collected aggregate post-closing receipts of \$40,807.34 (the "Post-Closing Receipts"). Approximately \$24,844.41 of the Post-Closing Receipts related to accounts receivable owing to the Company as at the Closing Date (the "Post-Closing A/R Collections"). As the Post-Closing A/R Collections satisfied the accounts

receivable owing to the Company in full, the residual Post-Closing Receipts of \$15,962.93 were paid to the Purchaser on or about February 18, 2021.

#### **RELATED PARTY A/R**

- 14. As detailed in the Second Report, as at the Date of Receivership, the following related party accounts receivable owing to the Company (collectively the "Related Party A/R") were recorded in the books and records of the Company:
  - (a) 1764239 Alberta Ltd. \$770,264;
  - (b) 1885731 Alberta Ltd. \$137,004;
  - (c) Odyssey Hotels Group Ltd. ("**Odyssey**") \$487,488;
  - (d) Ostrander Family Holdings ("**OFH**") \$388,465;
  - (e) Ostrander Family Trust ("**OFT**") \$1,970,000;
  - (f) Swift Hotels Partnership Group Ltd. ("SHPG") \$61,257; and
  - (g) Swift Hotels Swift Current Group Ltd. ("SHSCG") \$94,438.
- 15. On July 22, 2020, on application by Innovation, 1764239 Alberta Ltd. (o/a HomeStay Inn) and 1885731 Alberta Ltd. (o/a HomeStay Express) (collectively the "Insolvent Related Parties") were placed into Receivership by order of the Court of Queen's Bench of Alberta. The Insolvent Related Parties filed an assignment in bankruptcy on May 31, 2021. Accordingly, no further recoveries are expected in regard to the Insolvent Related Parties.
- 16. As detailed in the Second Report, in early November 2020, the Receiver filed statements of claim commencing actions against:
  - (a) Odyssey (the "**Odyssey Action**");
  - (b) OFH (the "**OFH Action**");

- (c) OFT (the "**OFT Action**");
- (d) SHPG (the "SHPG Action"); and
- (e) SHSCG (the "SHSCG Action").

On February 19, 2021, statements of defence were filed by Odyssey, OFT, and SHPG.

- 17. Summarized below is the status of the remaining Related Party A/R accounts as at the date of this Third Report:
  - (a) SHSCG As SHSCG failed to file a statement of defence in the SHSCG Action, default judgment as against SHSCG was awarded to the Receiver on January 27, 2021, in the amount of \$96,237.17 (inclusive of costs) (the "SHSCG Judgment") (attached hereto as Appendix C). The Receiver registered the SHSCG Judgment in the Saskatchewan Personal Property Registry ("PPR") on January 28, 2021. MLT Aikins LLP ("MLT Aikins"), the Receiver's legal counsel, conducted searches of the Saskatchewan Land Titles Registry and the PPR on January 29, 2021 to determine what assets of SHSCG may be available to enforce judgment against. As the searches did not disclose any exigible assets, no further enforcement steps have been taken and no further realizations are expected in regard to SHSCG.
  - (b) OFH The Receiver became aware of a limited statement of defence filed by OFH on March 25, 2021 (although the Receiver was not served with same). As the Receiver understands that Innovation has a registered judgment against OFH in the amount \$9,960,309.37, and as no assets of OFH have been identified to attach any judgment, the Receiver has not continued the OFH Action as no further realizations are expected.
  - (c) OFT and SHPG The Receiver has not identified any assets held by either OFT or SHPG to satisfy any potential judgment. Accordingly, after discussing the matter with Innovation, subject to the identification of any realizable assets, the Receiver does not propose to incur any further costs in pursuit of a judgment

- against either OFT or SHPG.
- Odyssey On June 10, 2021, the Receiver filed summary judgment application (d) materials with the Court of Queen's Bench of Alberta in the Odyssey Action, seeking judgment against Odyssey in the amount of \$487,488.43. Although the Receiver has not been able to confirm whether Odyssey has any realizable assets, during the interim receivership proceedings, the Interim Receiver was advised by Philp Krahn, Chief Financial Officer of Odyssey (and back office accounting support provider to Swift Hotels), of an investment account maintained by Odyssey at The Toronto-Dominion Bank ("TD"). On October 29, 2021, the Receiver obtained judgment against Odyssey in the Odyssey Action in the amount of \$488,288.43 (inclusive of costs) (the "Odyssey Judgment") (attached hereto as Appendix D). The Receiver has registered a Writ of Enforcement in the Alberta Personal Property Registry and has submitted a request to Alberta Land Titles to identify whether Odyssey owns any real property. As at the date of this Third Report, the Receiver has not identified any funds at TD. Accordingly, realizations resulting from the judgment against Odyssey remain uncertain.
- 18. As the Receiver has not formally discontinued the actions against OFH, OFT, and SHPG, nor has it been able to identify any realizable assets attributable to the Related Party A/R accounts to date, the Receiver respectfully requests Court approval to:
  - (a) Collect on the SHSCG Judgment and the Odyssey Judgment in the event that any assets are identified;
  - (b) Administer the prosecution of the OFH Action, the OFT Action, and the SHPG Action (if any assets are identified); and
  - (c) Discontinue the OFH Action, the OFT Action, and the SHPG Action if determined by the Receiver (in its sole discretion) to be appropriate;

(collectively the "Residual Related Party A/R Powers")

- subsequent to its discharge.
- 19. In order to complete the Residual Related Party A/R Powers, the Receiver proposes to hold back \$12,000 (the "Action Holdback") to address any costs (tariff or otherwise) that may arise in the event that the OFH Action, the OFT Action, and/or the SHPG Action is discontinued.

#### **DISPUTED PRIORITY FUNDS**

20. As detailed in the SAVO, the Receiver was ordered to hold back \$313,717.67 (the "CRA Holdback") in respect of CRA's claim against Swift Hotels for unremitted employee payroll source deductions, pending a written agreement to release same by CRA and Innovation, or further Order of the Court. On October 4, 2021, CRA and Innovation provided the Receiver with their written agreement comprising e-mail correspondence (attached hereto as Appendix E) to release the CRA Holdback to CRA, which the Receiver paid to CRA on October 6, 2021.

#### FEES AND DISBURSEMENTS OF THE RECEIVER AND ITS LEGAL COUNSEL

- 21. Paragraph 18 of the Receivership Order provides that the Receiver and its legal counsel shall pass their accounts from time to time. The Receiver is of the view that the primary party with an interest in regard to such accounts is Innovation, given that it holds a priority security interest over all of the Property of the Company. Innovation has been served with this Third Report and has been provided with all invoices of the Receiver within these proceedings.
- 22. Attached as Appendix F is a summary of the invoices of the Receiver for fees and disbursements incurred during the course of the proceedings for the period November 22, 2020 to September 30, 2021. The Receiver's accounts total \$86,243 in fees and disbursements, excluding GST. The Receiver estimates that its fees and disbursements incurred subsequent to September 30, 2021, to attend the October 29, 2021 Odyssey summary judgement hearing, finalize this Third Report, prepare for and attend the December 6, 2021 hearing, and to finalize the Receiver's discharge will approximate \$20,000 (plus GST) (the "Estimated Receiver Fees").

- 23. The fees charged by the Receiver are based on the amount of professional time expended at hourly billing rates, which vary depending upon the experience level and location of professionals involved. The average blended hourly rate charged by the Receiver in these proceedings for invoices issued to date is \$353 per hour. The rates charged by the Receiver are the normal rates and charges for engagements of this nature, and are comparable to the rates charged for the provision of services by other professional firms providing specialized financial advisory services.
- 24. The Receiver is of the view that its fees and disbursements are fair and reasonable in the circumstances and have been duly rendered in response to the required and necessary duties of the Receiver in accordance with the provisions of the Receivership Order.
- 25. Attached as Appendix G is a summary of the invoices of the Receiver's legal counsel for fees and disbursements incurred during the course of the proceedings for the period November 1, 2020 to October 31, 2021. The accounts total \$57,879 in fees and disbursements excluding PST and GST. The Receiver's legal counsel estimates that its fees and disbursements for all activities following October 31, 2021, including time spent to prepare for and attend the December 6, 2021 hearing, and to assist with finalizing the Receiver's discharge will approximate \$20,000 (plus taxes) (the "Estimated Legal Fees").
- 26. The Receiver has reviewed the invoices rendered by its legal counsel and finds them reasonable and validly incurred in accordance with the provisions of the Receivership Order.

#### STATEMENT OF RECEIPTS AND DISBURSEMENTS

- 27. The Receiver has prepared a Statement of Receipts and Disbursements for the period November 28, 2019 to November 30, 2021 for the Company, a copy of which is attached hereto as Appendix H. Total receipts were \$6,167,456 and total disbursements were \$6,032,004, resulting in \$135,452 being held in trust by the Receiver (the "Residual Trust Funds").
- 28. As at the date of this Third Report, in accordance with the SAVO, the Receiver has

made the following interim distributions:

- (a) \$1,017,913.18 to the City of Swift Current in respect of outstanding property taxes;
- (b) \$9,576.80 to the Government of Canada in respect of the Wage Earner Protection Program ("WEPP");
- (c) \$313,717.67 to CRA; and
- (d) \$2,025,000.00 to Innovation on account of the Innovation Indebtedness (as defined in the Second Report).
- 29. Additionally, the Receiver has repaid to Innovation the \$250,000 (plus interest) borrowed by the Receiver from Innovation under the Court authorized Borrowing Facility (as defined in the Receivership Order) in full.

#### APPROVALS SOUGHT

- 30. The Receiver believes that, other than distributing the Residual Trust Funds (excluding the Action Holdback, the Estimated Receiver Fees, and the Estimated Legal Fees) and performing certain administrative matters, the Receiver's mandate pursuant to the Receivership Order (the "Receiver's Mandate") is substantially complete.
- 31. For the reasons outlined above, the Receiver respectfully recommends that this Honourable Court grant an Order:
  - (a) Approving all activities and actions of the Receiver since the filing of the Second Report to date in relation to the discharge of its duties pursuant to the Receivership Order, as such actions of the Receiver are more particularly described in this Third Report;
  - (b) Approving the Third Report filed by the Receiver in these proceedings;
  - (c) Approving the Residual Related Party A/R Powers and authorizing the Receiver to implement and administer the Action Holdback;

- (d) Approving the fees and disbursements of the Receiver and its legal counsel for the period November 22, 2020 to September 30, 2021, and November 1, 2020 to October 31, 2021, respectively;
- (e) Approving the Estimated Receiver Fees and the Estimated Legal Fees to complete the within application and to finalize the receivership proceedings, without the requirement for taxation or formal passing of accounts;
- (f) Approving the Receiver's Statement of Receipts and Disbursements for the period November 28, 2019 to November 30, 2021;
- (g) Providing that, upon payment of the Residual Trust Funds (less the Action Holdback and the holdback(s) for the Estimated Receiver Fees and the Estimated Legal Fees), and any amounts remaining from the Action Holdback, the Estimated Receiver Fees, and the Estimated Legal Fees, to Innovation, the Receiver shall be discharged as Receiver, provided that notwithstanding such discharge:
  - The Receiver shall remain Receiver for the performance of such routine administrative tasks as may be required to complete the administration of these proceedings;
  - ii) The Receiver shall retain the Residual Related Party A/R Powers until the Related Party A/R accounts have been resolved to the satisfaction of the Receiver and Innovation;
  - iii) The Receiver shall be authorized to distribute the additional receipts, if any, realized from the Related Party A/R to Innovation up to the amount of the Innovation Indebtedness; and
  - iv) The Receiver shall continue to have the benefit of the provisions of all Orders made in these proceedings, including all approvals, protections, and stays of proceedings in favor of Deloitte in its capacity as Receiver;
- f) Providing that Deloitte shall be discharged from any and all liability, save and

except for any liability arising out of gross negligence or willful misconduct on the part of the Receiver; and

(h) Granting such further and other relief that the Court considers just and warranted in the circumstances.

# SALE APPROVAL AND VESTING ORDER

Before the Honourable Mr. Justice R.S. Smith in Chambers the 18th day of December, 2020.

On the application of Jeffrey M. Lee, Q.C. and Marek Coutu, counsel on behalf of Deloitte Restructuring Inc. (the "Receiver") in its capacity as the Court-appointed receiver of the assets, undertakings and properties of Swift Hotels Group Ltd. (the "Debtor") pursuant to the Order of this Court made on November 28, 2019 (the "Receivership Order"), and upon hearing from Jeffrey M. Lee, Q.C., counsel on behalf of the Receiver, and upon reading the Notice of Application dated December 4, 2020, the Second Report of the Receiver dated December 3, 2020 (the "Second Report"), the Confidential Supplement to the Second Report of the Receiver dated December 3, 2020 (the "Confidential Supplement"), the Brief of Law on behalf of the Receiver and a proposed draft Order, all filed; and the pleadings and proceedings herein:

The Court Orders:

#### SERVICE

1. Service of the Notice of Application on behalf of the Receiver and the materials filed in support thereof (collectively, the "Application Materials") shall be and is hereby deemed to be good and valid and, further, shall be and is hereby abridged, such that service of such Application Materials is deemed to be timely and sufficient.

#### APPROVAL OF TRANSACTION

- 2. The sale transaction (the "Transaction") contemplated by an asset purchase agreement (the "Sale Agreement") between the Receiver and First Canadian Management Corporation dated September 13, 2020, and amended on October 29, 2020 and November 2, 2020, respectively, and appended to the Confidential Supplement of the Receiver, for the sale to First Canadian Management Corporation (or its nominee) of the Debtor's right, title and interest in and to the assets described in the Sale Agreement (the "Purchased Assets") is declared to be commercially reasonable and in the best interests of the Debtor and its creditors and other stakeholders and is hereby authorized and approved, with such minor amendments as the Receiver may deem necessary. For clarity, 12547091 Canada Ltd. is the nominee of First Canadian Management Corporation and 12547091 Canada Ltd. is hereinafter referred to as the "Purchaser".
- 3. The Receiver is hereby authorized and directed to take such additional steps and execute such additional documents as may be necessary or desirable (including any steps necessary or desirable to satisfy and/or comply with any applicable laws, regulations or orders of any courts, tribunals, regulatory bodies or administrative bodies in any jurisdiction in which the Purchased Assets may be located) for the completion of the Transaction or for the conveyance of the Purchased Assets to the Purchaser, subject to such amendments as the Receiver and the Purchaser may agree upon, provided that any such amendments do not materially affect the Purchase Price.

#### **VESTING OF PROPERTY**

- 4. Upon the Receiver determining that the proposed Transaction has closed to its satisfaction and on terms substantially as approved by this Honourable Court pursuant to this Order, the Receiver shall deliver to the Purchaser a Receiver's certificate substantially in the form set out in **Schedule "A"** hereto (the "**Receiver's Certificate**").
- 5. The Receiver may rely on written notices from the Purchaser regarding fulfillment or, if applicable, waiver of conditions to closing of the Proposed Sale under the Sale Agreement and shall have no liability with respect to the delivery of the Receiver's Certificate.
- 6. Upon delivery of the Receiver's Certificate all of the Debtor's right, title and interest in and to the Purchased Assets described in the Sale Agreement and listed on **Schedule "B"** hereto shall, save and except for the encumbrances listed in **Schedule "C"** hereto (the "**Permitted Encumbrances**"), vest absolutely in the name of the Purchaser, free and clear of and from any and all security interests (whether contractual, statutory, or otherwise), hypothecs, interests, mortgages, trusts or deemed trusts (whether contractual, statutory, or otherwise), liens, judgments, enforcement charges, levies, charges, or other financial or monetary claims (collectively, "**Encumbrances**") and all rights of others, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, the "**Claims**") including, without limiting the generality of the foregoing:
  - (a) any encumbrances or charges created by the Receivership Order;
  - (b) all charges, security interests or claims evidenced by registrations pursuant to *The Personal Property Security Act*, 1993 SS 1993, c P-6.2, or any other personal property registry system; and
  - (c) those Encumbrances listed in **Schedule "D"** hereto:

and, for greater certainty, this Court orders that all of the Encumbrances (save and except for the Permitted Encumbrances) affecting or relating to the Purchased Assets are hereby expunged and discharged as against the Purchased Assets.

- 7. Upon delivery of the Receiver's Certificate to the Purchaser, the Receiver shall be and is hereby authorized to effect such discharges or revisions in the Saskatchewan Personal Property Registry as may be reasonably required to conclude the Transaction.

- 14. Immediately after the closing of the Transaction, the holders of the Permitted Encumbrances shall have no claim whatsoever against the Receiver or the Debtor.

  - a) the pendency of these proceedings;

- b) any applications for a bankruptcy order now or hereafter issued pursuant to the *Bankruptcy* and *Insolvency Act* (Canada) in respect of the Debtor and any bankruptcy order issued pursuant to such applications;
- c) any assignment in bankruptcy made in respect of the Debtor; and
- d) the provisions of any federal statute, provincial statute or any other law or rule of equity,

    - (ii) a holdback (to be held by the Receiver, until directed to release same by written agreement of Canada Revenue Agency and Innovation Creit Union, or further Order of the Court, whichever shall first occur) of the amount of \$313,717.67 in respect of Canada Revenue Agency's claim against the Debtor for unremitted employee source deduction arrears;
    - (iii) a distribution to the Government of Canada, in the amount of \$9,576.80 in respect of the Debtor's obligations pursuant to the *Wage Earner Protection Program Act*; and
    - (iv) to Innovation Credit Union ("Innovation"), after making the payments described above in paragraphs 19(a)(i), 19(a)(ii), 19(b)(i), 19(b)(ii), and 19(b)(iii) hereof, the Receiver shall pay the remainder of the Net Sale Proceeds to Innovation on account of the additional amounts owing by the Debtor to Innovation, which amounts were formerly

secured by Innovation's first mortgage, assignment of rents and general security agreement in respect of the Purchased Assets.

#### **MISCELLANEOUS MATTERS**

- 20. The Receiver, the Purchaser and any other interested party, shall be at liberty to apply for further advice, assistance and directions as may be necessary in order to give full force and effect to the terms of this Order and to assist and aid the parties in closing the Transaction, including, without limitation, an application to the Court to deal with interests which are registered against title to the Real Property after the time of the granting of this Order.
- 21. This Court hereby requests the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders as to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.
- 22. Service of this Order on any party not attending this application is hereby dispensed with. Parties attending this application shall be served in accordance with the Electronic Case Information and Service Protocol adopted in the Receivership Order.

#### APPROVAL OF ACTIVITIES AND DISBURSEMENTS OF THE RECEIVER

- 23. All activities, actions and proposed courses of action of the Receiver to date in relation to the discharge of its duties and mandate as receiver of the Property, as such Actions of the Receiver are more particularly described in the First Report of the Receiver dated December 11, 2019, the Second Report and the Confidential Supplement, as well as the statement of receipts and disbursements contained in the Report, shall be and are hereby approved and confirmed.
- 24. The professional fees and disbursements of the Receiver, as set out in the Second Report, are hereby approved without the necessity of a formal passing of its accounts.
- 25. The professional fees and disbursements of the Receiver's legal counsel, MLT Aikins LLP, as set out in the Second Report, are hereby approved without the necessity of a formal assessment of its accounts.

#### **SEALING ORDER**

26. Counsel for the Receiver having complied with Practice Directive #3, the Confidential Supplement shall be kept sealed and confidential and shall not form part of the public record, but rather shall be placed, kept separate and apart from all other contents of the Court file, in sealed envelopes each of which shall bear a notice which sets out the title of these proceedings and a statement that the contents are subject to a sealing order and shall only be opened upon further order of the Court or upon the filing of the Receiver's Certificate.

As you are aware, our office has been involved in discussions with David Smith, counsel for CRA, over the last several months, in an effort to negotiate a mutually agreeable resolution for payment of the Residual Holdback being maintained by the Receiver in this matter.

We were advised by Mr. Smith on September 17, 2021 that the conclusion of his office and CRA is that his client is entitled to the entire \$313,718 Residual Holdback being held by the Receiver. This was a disappointing response to have received in the circumstances of this case given the information we provided, the substantial losses suffered by our client and the costs the Credit Union has incurred in this matter.

Since having received CRA's position we have consulted with Innovation Credit Union regarding its options. Our client has instructed us to advise that it is not in a position to incur further time and costs required to pursue additional legal proceedings in this matter. Innovation Credit Union will not be advancing any further claim to the Residual Holdback. The Receiver may address pay out of the Residual Holdback directly with CRA/Mr. Smith.

We believe this matter should now be concluded. Thank you.

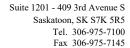
