ORDER

THIS MOTION, made by Deloitte Restructuring Inc., the court-appointed liquidator (the "Liquidator") of the assets, undertakings and property of Taylor Bros. Farm Ltd. ("TBF") and Edwin Potato Growers Ltd. ("EPG") for an Order granting the Liquidator security for its costs incurred in

- 1. THIS COURT ORDERS that the Appellants Duanne Taylor and 5608067 Manitoba Ltd. shall post security for costs in the amount of FIVE THOUSAND DOLLARS (\$5,000.00) by making payment into this Honourable Court within 30 days of the release of these reasons.
- THIS COURT FURTHER ORDERS that the Liquidator's Motion requiring the Appellants Duanne Taylor and 5608067 Manitoba Ltd. to pay the costs awarded in favour of the Liquidator by the Order of the

Honourable Mr. Justice Toews pronounced on February 16, 2021 in Queen's Bench File No. CI 15-01-97066 is hereby dismissed.

3. THIS COURT ORDERS that the Appellants Duanne Taylor and 5608067 Manitoba Ltd. shall pay to the Liquidator one set of costs associated with this Motion in accordance with Tariff "D" of the Court of Appeal Rules.
