1. An Order extending the Amended and Restated Initial Order granted July 5, 2018 in these proceedings by the Honourable Mr. Justice N.G. Gabrielson (the "Initial Order") pursuant to the Companies' Creditors Arrangement Act, RSC 1985, c C-36 (the "CCAA"), as most recently amended by the Order of the Honourable Mr. Justice N.G.
