**The Court orders:**

3. That the remainder of the Fee Holdback Funds which were paid into Court pursuant to the January 24, 2018 Order of Justice Gabrielson, being \$24,934.42 plus applicable interest, are directed to be paid out to Kanuka Thuringer LLP, as solicitors for the secured creditor Industrial Properties Regina Limited.
4. There are no costs of this application ordered to any party.
