Remedy claimed or sought:

1. An Order:

- a. abridging the time for service of notice of this Application to the time actually given and deeming service upon the parties served as good and sufficient;
- b. approving the proposed minimum guarantee auction sales process (the "Auction") by Osman Auctions ("Osman") of the equipment assets of Elements West Inc. and Damen Trucking Inc. (the "Equipment") as set out in the First Report of the Receiver dated January 31, 2017 (the "First Report"), substantially in the form attached hereto as Schedule "A", or on such further and other terms as this Honourable Court may direct;
- c. declaring that Division 4 of Part 6 of the *Rules of Court* does not apply to this Application, and that the Receiver's Confidential Schedule 2 as outlined in the First Report (the "Confidential Schedule") be temporarily sealed until after the date of the Auction of the Equipment or until further Order of the Court, substantially in the form attached hereto as Schedule "B", or on such further and other terms as this Honourable Court may direct;
- d. alternatively, a direction that the Confidential Schedule does not have to be filed with the Clerk of the Court unless and until the Auction of the Equipment has occurred or until further Order of the Court;
- e. alternatively, a temporary Restricted Court Access Order pursuant to Rule 6.28 of the Rules of Court sealing the contents of the Confidential Schedule until the Auction of the Equipment has occurred or until further Order of the Court; and
- f. such further or other relief as may be requested of the Court by the Receiver.

Grounds for making this application:

Proposed Sale Process

- 2. On December 2, 2016, the Court of Queen's Bench of Alberta granted an order appointing Deloitte Restructuring Inc. as Receiver of Elements West Inc. ("Elements West") and Damen Trucking Ltd. ("Damen Trucking"; Elements West and Damen Trucking collectively the "Companies") pursuant to an application may by Royal Bank of Canada (the "Receivership Order").
- 3. By the Receivership Order, the Receiver was empowered to, *inter alia*, market any and all of the personal property of the Companies for sale, and to sell the property or part or parts thereof without Court approval if the aggregate consideration does not exceed \$250,000.00 and with Court approval where the aggregate consideration exceeds such sum.
- 4. The aggregate consideration for the proposed sale of the Equipment of the Companies will exceed \$250,000.00, and accordingly Court approval of such sale is required.
- 5. The Receivership Order empowers the Receiver to apply for any vesting Order or other Orders necessary to convey the property of the Companies free and clear of all liens or encumbrances, and the Receiver requires a vesting Order such that it may convey free and clear title to the purchasers of the Equipment of the Companies.

6. The proposal submitted by Osman for the Auction of the Equipment of the Companies is the best offer received by the Receiver to maximize the realizable value of the Equipment the Companies.

Sealing Order

7. The Confidential Schedule contains confidential information of a commercial nature which, if disclosed to third parties prior to the Auction set out herein, could materially jeopardize the same, or should any Equipment not sell at the Action, could materially jeopardize the value that the Receiver is subsequently able to obtain from the sale of the Equipment, and as such, it is appropriate that the Court dispense with filing the Confidential Schedule with the Clerk of the Court until the Auction has occurred, or grant an interim sealing order in relation thereto.

UPON THE APPLICATION of Deloitte Restructuring Inc. in its capacity as receiver of the property of Elements West Inc. ("Elements West") and Damen Trucking Ltd. ("Damen Trucking") (the "Receiver"); AND UPON READING the Receivership Order granted by the Honourable Mr. Justice B.R. Burrows in these proceedings on December 2, 2016; AND UPON NOTING that the Receiver has solicited offers for the sale of the personal property of Elements West and Damen Trucking (the "Equipment"); AND UPON NOTING that Osman Auctions ("Osman") has presented an offer to sell the Equipment by way of a minimum guarantee auction (the "Auction"); AND UPON READING the First Report of the Receiver dated January 31, 2017 (the "First Report") and the Application filed herein and proof of service thereof and the pleadings and proceedings had and taken herein; AND UPON it appearing that the sale of the Equipment is in the best interests of the creditors of Elements West and Damen Trucking; AND UPON HEARING from counsel for the Receiver and all other interested parties:

IT IS HEREBY ORDERED THAT:

- 1. The time for service of notice of the application for this Order and all materials in support of such notice is deemed good and sufficient upon all interest persons and the time for such service is abridged to the time actually given and all further service is dispensed with.
- 2. All steps and activities taken by the Receiver, including but not limited to the Receiver's activities as described in the First Report, are hereby approved.
- 3. The sale of the Equipment pursuant to the Auction is hereby authorized, ratified and confirmed by this Honourable Court, subject to the remaining terms of this Order.
- 4. The Receiver is hereby permitted to release Equipment to any priority secured creditor(s) who has proven to the satisfaction of the Receiver a priority interest in such Equipment ("Priority Secured Creditor") who inform the Receiver in writing within seven (7) days of this Order that the Priority Secured Creditor does not wish for the Receiver to realize upon such secured Equipment, provided that such Priority Secured Creditor(s) pay 10% of the Osman guarantee (net of commission costs) with respect to the Equipment secured by the Priority Secured Creditor(s) as an allocation of the Priority Secured Creditor(s) share of super priority claims as against Elements West or Damen Trucking and the Receiver's administration costs within seven (7) days of demand being made by the Receiver, failing which the Receiver will dispose of the Equipment in the minimum guarantee auction and remit 90% of the net realized amount to the Priority Secured Creditor(s).
- 5. Upon Osman conducting the Auction of the Equipment and upon the successful bidder for each item or items of the Equipment paying the full purchase price (the "Highest Bid Purchase Price") for such Equipment (the "Purchased Equipment"), the successful bidder for the Purchased Equipment shall be entitled to possession of such Purchased Equipment, and Elements West or Damen Trucking and all other persons claiming through or under Elements West or Damen Trucking do stand absolutely debarred and foreclosed of and from all of their estate, right, title, interest and equity of redemption in the Purchased Equipment.
- 6. Upon the Receiver being in receipt of the Highest Bid Purchase Price, the Highest Bid Purchase Price shall stand in the place and stead of the Purchased Equipment and all security against the Purchased Equipment existing immediately prior to the granting of this Order shall be deemed to apply to the Highest Bid Purchase Price and all priorities with respect to such security which existed against the Purchased Equipment immediately prior to the granting of this Order shall apply, mutatis mutandis, to the Highest Bid Purchase Price. All Equipment which remains unsold following the Auction shall be dealt with by the Court upon further application.
- Any secured creditor that has registered a security interest against a serial number (with respect to a serial number good, as defined in the *Personal Property Security Act*, RSA 2000, c P-7 and any regulation thereunder, of the Purchased Equipment) sold pursuant to the Action may discharge its security number registration against the Purchased Equipment and the discharge shall not affect the secured party's claim or priority to the proceeds of the sale of the Purchased Equipment as is otherwise provided for in this Order or any other Order of this Honourable Court granted in these proceedings.
- 8. If a secured creditor does not discharge a security interest registered with respect to a serial number good of the Purchased Equipment sold pursuant to the Auction upon the request of the Receiver, the Receiver may, absent a written objection by the secured creditor to the Receiver within 10 days following the request having been made, discharge the secured creditor's

registration in a personal property security registry with respect to the Purchased Equipment and the discharge of such registration shall not affect the secured party's claim or priority to the proceeds of the Purchased Equipment as is otherwise provided for in this Order or any other Order of this Honourable Court granted in these proceedings.

- 9. Service of this Order may be effected upon those persons (directly or through legal counsel) who were served with a copy of the Application for this Order by facsimile or electronic mail, and such service shall constitute good and sufficient service. Service is deemed to be effected the next business day following the transmission or delivery of such documents.
