("Graham Brothers") (the "Trustee" or the "Receiver"); AND UPON reviewing the Receiver's Reports filed with this Honourable Court including, but not limited to, the second report; AND UPON reviewing the list of the property of Graham Brothers attached hereto as Schedule "A" that the Receiver proposes to sell (the "Sale Assets"); AND UPON noting that Royal Bank of Canada ("RBC") and 1615046 Alberta Ltd. ("161 Ltd.") are the only known creditors holding security on the Sale Assets; AND UPON noting that RBC and 161 Ltd. are supportive of the sale of the Sale Assets; AND UPON reviewing the Affidavit of Service of service of notice of this Application and

supporting documents; AND UPON hearing counsel for the Receiver; IT IS HEREBY ORDERED AND ADJUDGED THAT:

- Service of notice of this Application and supporting materials by the method and as described in the Affidavit of Service filed in the within action is hereby deemed good and sufficient and time for service is abridged as required.
- 2. Upon obtaining the approval of RBC and 161 Ltd., the Receiver be and is hereby at liberty to sell the Sale Assets of Graham Brothers listed on Schedule "A" attached to this Order by either public auction or private sale.
