Re: Notice of Intention to Make a Proposal

On August 9, 2013, Grantech filed a Notice of Intention to Make a Proposal (the "NOI") under Section 50.4(1) of the *Bankruptcy and Insolvency Act* (the "BIA").

Attached is a copy of the NOI, which includes a list of Grantech's known creditors as well as a letter from Deloitte Restructuring Inc. consenting to act as Trustee under the proposal.

Grantech must now file a proposal within 30 days of the filing of the NOI or within any further extension of that period that may be granted by the Court of Queen's Bench of Alberta. Once a proposal has been filed, a meeting of creditors to consider the proposal will be held within 21 days.

Pursuant to Section 69 of the BIA, all proceedings against Grantech are now stayed and service to Grantech cannot be discontinued.
