Further to the *Interim order regarding the final settlement of the debtor's outstanding balance with the IATA clearing house and for the final distribution of BSP & CASS proceeds* rendered by the Honourable Justice Brian Riordan on September 19, 2012 with respect to the above captioned matter (the «**Order**»), we wish to set forth certain details regarding the « **Approved Process** » contained at pages 3 to 6 of the Order, as follows:
