TAKE NOTICE that an application will be made by the Applicants to the Honourable Mr. Justice Burnyeat at the courthouse at 800 Smithe Street, in the City of Vancouver, in the Province of British Columbia on <a href="Thursday">Thursday</a>, April 5, 2012 at 9:00 a.m. for an Order, substantially in the draft form described in Part 1 below and such other and further relief as Counsel for the Applicants may request and this Honourable Court deems just.

#### PART 1: ORDER SOUGHT

1. An Order, substantially in the draft form attached hereto as **SCHEDULE "B"** extending the stay of proceedings and other relief granted under the Initial Order until May 7, 2012.

### **PART 2: FACTUAL BASIS**

- 1. On July 7, 2011, Please Mum filed a Notice of Intention to Make a Proposal under section 50.4 of the *Bankruptcy and Insolvency Act* (the "BIA"). Deloitte & Touche Inc. was appointed as the Proposal Trustee of Please Mum. Pursuant to a number of extensions granted by the Court under the BIA, the time for Please Mum to file a Proposal was extended to December 5, 2011.
- 2. On December 5, 2011 Please Mum obtained the Initial Order granting, among other things, a stay of proceedings to January 5, 2012 and the continuation of Please Mum's restructuring under the CCAA, with Deloitte as the Monitor of the Petitioners.
- 3. On January 5, 2012 Please Mum obtained an Order extending the relief granted under the Initial Order to April 5, 2012.

## Closing of the Sale of the Lands

- 4. Pursuant to a purchase and sale agreement, dated April 4, 2011, as amended and extended, 0710345 B.C. Ltd. ("071") contracted to sell lands located at 333 Woodland Drive, Vancouver, B.C. (the "Lands") for the purchase price of \$13.35 million.
- 5. The Applicants obtained an Order on March 28, 2012 to approve certain steps of a tax savings transaction to enable 071 to use Bossa Nova Fashions Ltd.'s tax losses to shelter or partially shelter the gain on the Lands.
- The sale of the Lands closed on March 29, 2012.

#### Proposed Extension

- 7. Throughout these proceedings, it has been the intention of 071 and Please Mum to raise funds through the sale of the Lands to assist in the recapitalization and restructuring of Please Mum, if feasible.
- 8. Please Mum requires an extension of the relief granted under the Initial Order in order to engage in negotiations with its creditors (including former landlords of disclaimed leases) to determine whether an agreement can be reached regarding the terms of an acceptable Plan of Compromise and Arrangement

- 9. If those negotiations are favourable, Please Mum intends to initiate a Claims Process and file a Plan of Compromise and Arrangement for the benefit of its stakeholders.
- 10. Please Mum has been and continues to act in good faith and with due diligence in these proceedings.

### PART 3: LEGAL BASIS

- Companies' Creditors Arrangement Act, R.S.C. 1985, c. C-36, as amended, including section 11.02 therein; and
- 2. the inherent jurisdiction of this Honourable Court.

## PART 4: MATERIAL TO BE RELIED ON

- Pleadings and proceedings previously filed herein;
- Monitor's Second Report to the Court, to be filed;
- 3. Affidavit #4 of Kathryn Adrian sworn April 2, 2012; and
- 4. Such further and other evidence as may be filed.
