Deloitte Restructuring Inc. (the "Receiver") in its capacity as the Court-appointed Receiver and Manager of the assets, collateral and undertaking of the Respondent 11016946 Canada Inc. (the "Company"), and the Company's real property located at 123-125 Prince William Street and 60 Water Street, St. John, New Brunswick (the "Property"), seeks:

- 1. An Order abridging time (if required) pursuant to Rule 6 of *Bankruptcy and Insolvency General Rules*, C.R.C. 1978, c. 368, as am.;
- 2. An Order for Confidentiality pursuant to Civil Procedure Rule 85.04 as regards the Confidential Supplement to the Second Report of the Receiver dated November 30_, 2023 (the "Confidential Supplement");
- 3. An Order pursuant to s. 243(1)(c) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as am.
