

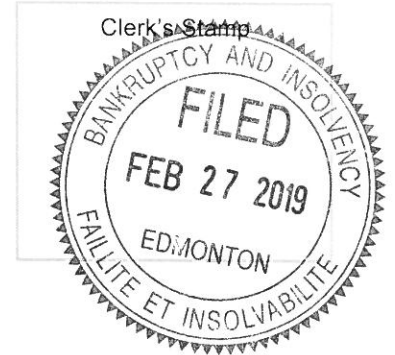

**Remedy claimed or sought:**

1. An Order abridging time for service of notice of this Application and supporting materials as may be required.
2. An Order extending the time for filing of a Proposal in these proceedings to April 24, 2019, being forty-five (45) days from March 10, 2019.
3. An Order granting the Proposal Trustee, Deloitte Restructuring Inc. (the "Proposal Trustee") and Ogilvie LLP, counsel to B.W. Rig Supply Inc. ("BW Rig") an administrative charge over the assets of BW Rig as security for fees and disbursements.

4. An Order authorizing BW Rig to serve by email all future materials in the within action only on those unsecured creditors of BW Rig who have unsecured claims in excess of \$20,000.00 and who provide to counsel for BW Rig, within twenty-one (21) days of service of this Order an email address for service of future documents. For those unsecured creditors with claims over \$20,000.00 who do not provide an email address as required, or those unsecured creditors with claims of less than \$20,000.00, BW Rig seeks an Order deeming service of all future materials effective by posting on Deloitte Restructuring Inc.'s website.

**Grounds for making this application:**

5. On February 8, 2019, BW Rig filed a Notice of Intention to Make a Proposal to its creditors (the "NOI").
6. Since the filing of the NOI, BW Rig has diligently proceeded to formulate a Proposal to its creditors, but has not yet completed all the tasks needed in order to formulate and present a Proposal to its creditors.
7. BW Rig requires an extension of the time to file a Proposal to its creditors to complete the preparation of its Proposal and presentation thereof to its creditors.
