On December 23, 2014, by order of the Supreme Court of British Columbia (the "Bankruptcy Order") the Company was assigned into Bankruptcy. On December 30, 2014 the Bankruptcy Order was stayed as a result of an appeal filed by the director of the Company. The appeal and the resulting stay were dismissed on December 2, 2015, and the Bankruptcy proceedings resumed on that date.

We enclose a notice of the meeting of creditors which is to be held on December 18, 2015 at 10:00 a.m. at the offices of Deloitte Restructuring Inc. ("Trustee"), 2800-1055 Dunsmuir Street, Vancouver, British Columbia.

- Proof of claim and general proxy form.





On the July 17, 2013, Grant Thornton Limited was appointed as Receiver (the "**Receiver**") in respect of the property and undertakings of R. Home Supply Centre Ltd. (the "**Company**"). The Company was subsequently assigned into bankruptcy on December 23, 2014 and Deloitte Restructuring Inc. was appointed as Trustee in Bankruptcy (the "**Trustee**"). The attached Statement of Affairs is prepared as at July 17, 2013 and is based on the Notice of Statement of the Receiver dated July 26, 2013. The following notes provide further details on the realizations of the Company's assets by the Receiver from July 17, 2013 to October 21, 2014 and are based on the Receiver's "Receivership Statement of Receipts and Disbursements", dated October 21, 2014:

Note 1) Inventory/Furniture

The Receiver initiated a sale process to liquidate all inventory and furniture on-hand. The gross proceeds of the sale of inventory and furniture were \$786,213.

Note 2) Accounts Receivable

The Receiver collected outstanding trade receivable of \$175,489.

Note 3) Cash

The Receiver realized \$12,567 relating to the Company's cash on-hand.

Note 4) Real Property

The Trustee understands that foreclosure proceedings have commenced with respect to the encumbered Dawson Creek property. The Trustee believes that the Tumbler Ridge property is unencumbered. The value of the Tumbler Ridge property is unknown at this time. Both properties are reflected in the Statement of Affairs at the Company's net book value as at July 17, 2013.

Note 5) Securities



If the bankrupt is a corporation, you would be considered to be related to it if you were a shareholder or if your company was controlled by the same shareholders as the bankrupt corporation."

PARAGRAPH 6

- All claimants must attach a detailed list of all payments or credits received or granted as follows:
 - Within the three months preceding the bankruptcy / proposal, in the case where the claimant and debtor are not related;
 - Within the twelve months preceding the bankruptcy / proposal, in the case where the claimant and debtor are related.
