THE APPLICATION of Deloitte Restructuring Inc. (formerly Deloitte & Touche Inc.) ("**Deloitte**"), the Court-appointed Monitor (the "**Monitor**") and formerly the proposal trustee (the "**Trustee**") of Please Mum Partnership, Elia Fashions Ltd., and Boss Nova Fashions Ltd., coming on for hearing before me this day by teleconference at the Courthouse, 800 Smithe Street, Vancouver, British Columbia; AND UPON HEARING Jonathan B. Ross, Counsel for the Monitor, and no one else appearing although duly served; AND UPON READING the pleadings and materials filed herein, including the Monitor's Final Report dated May 27, 2021 and filed herein;

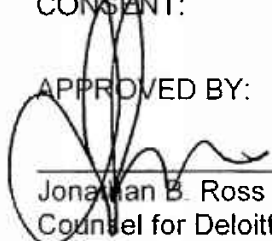
THIS COURT ORDERS AND DECLARES that:

1. the fees of the Trustee as set out in the Report and in the Affidavit of Jeff Keeble, sworn on May 28, 2021 (the "**Deloitte Fee Affidavit**") are hereby approved pursuant to Section 39(3) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3;

2. the activities of the Monitor as set out in the Monitor's Final Report dated May 27, 2021, (the "Report") and the three other reports filed by the Monitor herein are hereby approved;
3. the fees and disbursements of the Monitor and the Monitor's legal counsel Gowling WLG (Canada) LLP (formerly Gowling Lafleur Henderson LLP) as set out in the Report, in the Deloitte Fee Affidavit, and in the Affidavit of Colin Brousson, sworn on June 1, 2021 are hereby approved;
4. Deloitte Restructuring Inc. is released and discharged from its duties as Monitor in relation to the Petitioners in the CCAA proceedings and the appointment of Deloitte Restructuring Inc. as Monitor is hereby terminated, subject to Deloitte Restructuring Inc. filing Form 3 of the CCAA Regulations with the Superintendent of Bankruptcy;
5. Deloitte is released and discharged from any and all claims of any nature and kind whatsoever that any party or person may now have or may hereafter have against Deloitte by reason of or in any way related to or arising out of the acts or omissions of Deloitte while acting as Monitor herein and including, without limitation, any claim or liability relating to matters that were raised or which could have been raised in the within proceedings, except for gross negligence or wilful misconduct;
6. notwithstanding any provision of this Order, nothing contained in this Order shall affect, vary, derogate from or amend any of the rights and protections in favour of the Monitor at law pursuant to the Initial Order, all of which are expressly continued and confirmed;
