Ottawa ON

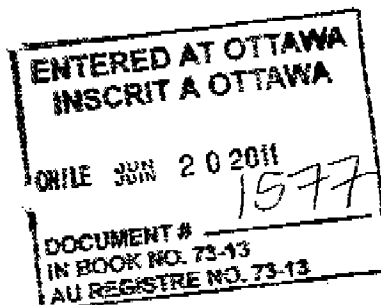
ON READING the Motion Record of the Monitor and the consent of the parties,
