## **ORDER**

(re: Mountaineers II)

UPON the application of the Applicants in these proceedings (collectively, "UBG"); AND UPON having read the Application of the Applicants, dated December 11, 2012, the Affidavit of Robert Friesen, dated December 11, 2012 (the "Friesen Affidavit"), the Seventh Report of the Monitor, dated December 11, 2012 (the "Seventh Report"), the Affidavit of Anna Collister, dated December 13, 2012 (the "Service Affidavit"), and such other material in the pleadings and proceedings as is deemed necessary; AND UPON hearing counsel for UBG, counsel for the Monitor, and other interested parties; IT IS HEREBY ORDERED AND DECLARED THAT:

## Service

 The time for service of notice of this application is abridged to the time actually given and service of the Application and supporting material as described in the Service Affidavit is good and sufficient, and this hearing is properly returnable before this Honourable Court today and further service thereof is hereby dispensed with.

## **Mountaineers II**

- 2. UBG is hereby authorized to enter into a listing agreement (a "Listing Agreement") with a qualified independent real estate agency in respect of the sale of the Mountaineers II Lands (as defined in the Friesen Affidavit) (the "Mountaineers II Sales Process"), on terms and conditions to be approved by the Monitor and as described in the Seventh Report including, but not limited to, the ability of the Mountaineers II investors to engage in the Mountaineers II Sales Process without being subject to any real estate commission, and UBG, in conjunction with the Monitor, are hereby authorized and directed do all such things as are reasonably necessary to conduct and give full effect to a Listing Agreement and carry out their respective obligations thereunder.
- 3. Any sale or transaction resulting from the Mountaineers II Sales Process shall remain subject to further Court approval.

## General

- 4. The Mountaineers II Sales Process may be altered or amended by the Monitor in any non-substantive manner to give full or better effect to the sales procedure hereby approved.
- 5. UBG, the Monitor, or any interested party may apply to this Court for advice and direction on notice to any party likely to be affected by the Order sought or on such notice as this Court directs.
- 6. UBG shall serve, by courier, facsimile transmission, e-mail transmission, or ordinary post, a copy of this Order on all parties present at this application and on all parties who received notice of this application or who are presently on the service list established in these proceedings, and service on any or all other parties is hereby dispensed with. Service affected as aforesaid shall be good and sufficient service.
