**THE COURT ORDERS THAT:**

1. The Receiver shall be and is hereby authorized to cease to perform the two (2) Purchase Contracts between Tyler Smith, on one hand, and Richardson Pioneer Limited, on the other, each dated effective July 24, 2020 and numbered 763048141 and 763048142, respectively.
2. The Receiver shall have the costs of this application against Richardson Pioneer Limited, to be taxed on the basis of Column 2 of the tariff.
