SIXTH REPORT OF DELOITTE RESTRUCTURING INC., RECEIVER OF ARC PRODUCTIONS LTD., ET AL. (May 12, 2017)

- 1. This report is filed by Deloitte Restructuring Inc. (the "Receiver") in its capacity as receiver of the assets, properties and undertakings of Arc Productions Ltd. and the other corporate Defendants (collectively, "Arc" or the "Company") and the other Property as desfined in the Receivership Order granted by the Honourable Mr. Justice Penny on Wednesday, August 10, 2016 (the "Receivership Order").
- 2. The Receiver has previously provided the Court with the following reports:

- (a) the First Report of the Receiver (in its former capacity as Interim Receiver) dated August 8, 2016 in connection with the Receiver's recommendation that a full receivership order be granted;
- (b) the Second Report of the Receiver dated August 16, 2016 in connection with the Receiver's recommendation for the approval of the sale of substantially all of the assets and undertaking of Arc to Jam Filled Entertainment (Toronto) Inc. ("Jam Filled");
- (c) the Third Report of the Receiver dated September 2, 2016 in connection with the Receiver's assignment of the Peter Street lease to the landlord and other relief;
- (d) the Fourth Report of the Receiver dated December 5, 2016 in connection with the Receiver's recommendation to assign Arc into bankruptcy; and,
- (e) the Fifth Report of the Receiver dated March 27, 2017 in connection with the Receiver's recommendation to make distributions of available proceeds in the receivership estate to Arc's senior secured lender, Grosvenor Park Media Fund L.P. ("GP").

Copies of these reports and other materials relevant to the Receivership can be accessed from the Receiver's website at www.insolvencies.deloitte.ca.

3. The Receiver has prepared this sixth report (the "Sixth Report") in its capacity as a Court-appointed officer solely for the purpose outlined herein. Parties using the Sixth Report, other than for the purpose outlined herein, are cautioned that it may not be appropriate for their purposes. Unless otherwise provided, all dollar amounts contained in this Sixth Report are expressed in Canadian Dollars. Unless otherwise provided, all other capitalized items not otherwise defined this Sixth Report are as defined in the First through Fifth Reports.

A. Purpose of the Report

4. The Receiver has prepared this Sixth Report to advise the Court and the Service List of the Receiver's intention to make a further distribution of \$4,500,000 to GP from available funds on hand, and to report on the source of these funds.

B. April 18, 2017 Distribution Order

5. Attached as Appendix "A" is the Distribution Order of the Ontario Superior Court of Justice (Commercial List) dated April 18, 2017 (the "Distribution Order"). Paragraph 4 of the Distribution Order provides that "subject to paragraph 5 of this Order, the Receiver be and is hereby authorized to distribute to GP from time to time all funds coming into its hands, subject to such reserves as the Receiver may deem prudent in the circumstances, up to the amount of \$43,953,400". Paragraph 5 of the Distribution Order states that "any distributions by the Receiver hereunder of proceeds of the realization or collection of tax credits of Arc, where the Receiver has notice of the interests of parties other than GP

- claiming ownership, security interests, or both in such tax credits or their proceeds, shall only be made upon further Order of the Court on notice to GP and to such other parties".
- 6. To date, the Receiver has distributed C\$579,388 and US\$147,245 to GP (for a total C\$ equivalent of \$770,807 at US\$1 = C\$1.30).
- 7. Attached as Appendix "B" is the Receiver's Statement of Receipts and Disbursements for the period from August 2, 2016 to May 8, 2017 which indicates that there are available funds on hand for further distribution to GP of \$4,500,000.
- 8. The source of funds for this recommended distribution are film tax credit recoveries from Arc's affiliated companies TF I Productions Inc., BL II Productions Inc., and Eggs Ltd., as well as post-receivership HST recoveries. Total film tax credits received to date by the Receiver are \$6,327,588 and are detailed on the attached Appendix "C". Not included in these receipts are provincial film tax credit recoveries due to Arc for 2012 productions of \$1,187,479 which have been withheld by Canada Revenue Agency and set off against Arc's pre-receivership liabilities for employee source deductions, employer liabilities, penalties and interest totaling \$1,162,636, and a July 2016 HST liability of \$24,843.
- 9. After due consideration of the source of the funds for this proposed distribution, the Receiver is not aware of any party who may have a claim to these proceeds in priority to the interests of GP either as an owner or secured creditor. Notwithstanding, the Receiver has prepared, served and filed this Sixth Report to notify the Service List of its intention to make this distribution on May 26, 2017 or immediately thereafter in accordance with the Distribution Order.
